**REQUEST TO RETURN TO ELIGIBLE LIST – STEPHEN LIAO** 

Correspondence has been received from Margaret Huebner, Director of Human Resources, Harbor Department requesting Stephen Liao's name be returned to the Civil Engineer eligible list. On April 22, 2014, while on probation, Mr. Liao was released from his position as a Civil Engineer at the Harbor Department. He is in agreement with his name being returned to the Civil Engineer eligible list.

The Civil Engineer eligible list (K11NN-13, test #01) was established on June 3, 2013 and is currently scheduled to expire June 4, 2014. Civil Engineer is a non-competitive list with all candidates being certified to vacancies. Civil Engineers are used throughout the City in several departments, one of which is the Harbor Department. The Harbor Department has submitted this request as they believe Mr. Liao may be "a better fit for another department."

Per Section 90 of the Civil Service Rules and Regulations: An employee may be terminated at will any time during their probationary period. If, in the opinion of the department head and the Commission, the person is still regarded as capable of performing in some other position in the same classification, his/her name may be returned to the eligible list established for the classification.

If the Commission concurs with the Harbor Department's request, Mr. Liao's name would be returned to the Civil Engineer eligible list and certified to vacancies during the life of the eligible list.
