A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LONG BEACH, CALIFORNIA, ORDERING, CALLING, PROVIDING FOR AND GIVING NOTICE OF A SPECIAL MUNICIPAL ELECTION TO BE HELD IN THE 2ND COUNCILMANIC DISTRICT IN THE CITY OF LONG BEACH ON TUESDAY, THE 6TH DAY OF JUNE , 2006, FOR THE PURPOSE OF FILLING THE OFFICE OF MEMBER OF THE CITY COUNCIL FOR THE 2ND COUNCILMANIC DISTRICT FOR THE REMAINDER OF THE TERM OF OFFICE TERMINATING ON THE 3RD TUESDAY OF JULY, 2008

WHEREAS, Daniel Baker, Councilmember from the 2nd Councilmanic District, has resigned his Council office effective February 8, 2006; and

WHEREAS, on February 14, 2006, the Office of Member of the City Council for the 2nd Councilmanic District was declared vacant pursuant to Long Beach Charter Section 204;

NOW, THEREFORE, the City Council of the City of Long Beach does resolve as follows:

Section 1. Pursuant to Long Beach Charter Section 204, a Special Municipal Election is ordered, proclaimed and called to be held in the 2nd Councilmanic District in the City of Long Beach, California, between the hours of 7:00 A.M. and 8:00 P.M. on Tuesday, the 6th day of June, 2006, to fill the Office of Member of the City Council for the 2nd Councilmanic District for the remainder of the present term which terminates on the 3rd Tuesday of July, 2008.

1 Sec. 2. Notice is given of the holding and of the time and place of
2 the Special Municipal Election. The candidate receiving a plurality of the votes cast for
3 all candidates shall be deemed to be and declared by the City Council to be elected to
4 the Office of Member of the City Council for the 2nd Councilmanic District for the
5 remainder of the present term which terminates on the 3rd Tuesday of July, 2008.
6 Nomination papers shall be filed during the period commencing on February 27, 2006,
7 at 7:30 A.M. and ending at 4:30 P.M. on March 10, 2006. All other particulars shall be
8 held in accordance with the provisions of law governing the conduct of such elections in
9 the City of Long Beach.


10 Sec. 4. This resolution shall take effect immediately upon its
