FOURTH AMENDMENT TO AGREEMENT NO. 33803

THIS FOURTH AMENDMENT TO AGREEMENT NO. 33803 is made and entered, in duplicate, as of July 20, 2020 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 14, 2020, by and between EYESTONE-JONES ENVIRONMENTAL, LLC DBA EYESTONE ENVIRONMENTAL (formerly known as MATRIX ENVIRONMENTAL, LLC), a California limited liability company ("Consultant"), with a place of business at 2121 Rosecrans Avenue, Suite 3355, El Segundo, California 90245, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed on-call environmental consulting services; and WHEREAS, City and Consultant (the "Parties") entered into Agreement No.

33803 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to increase the total not to exceed amount to \$375,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to increase the total not to exceed amount to \$725,000 and extend the term; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to additionally extend the term; and

WHEREAS, the Parties desire to further extend the term to July 13, 2021 for Environmental Impact Report services for the 100 East Ocean Boulevard Project;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 2 of the Agreement is hereby amended to read as follows:
- "2. <u>TERM.</u> The term of this Agreement shall commence at midnight on January 1, 2015, and shall terminate at 11:59 p.m. on July 13, 2021, unless sooner terminated as provided in this Agreement, or unless the services or the Project is

completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33803 are ratified and confirmed and shall remain in full force and effect.
