AGREEMENT

THIS AGREEMENT is made and entered, in duplicate, as of April 25, 2007 for reference purposes only, pursuant to Resolution No. RES-07-0039, adopted by the City Council of the City of Long Beach at its meeting on March 20, 2007, by and between WONDRIES CHEVROLET ("Contractor"), a California corporation and a division of WONDRIES FLEET GROUP, located at P.O. Box 1340, Alhambra, California 91801-3330 and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, Section 1802 of the Long Beach City Charter permits the City to make purchases under the purchasing contracts of other governmental agencies when authorized to do so by a resolution; and

WHEREAS, the City desires to purchase two (2) 2007 Chevrolet Suburban 2500 4WD SUVs and may desire to purchase additional Chevrolet Suburban SUVs; and

WHEREAS, the County of Los Angeles has a contract for the purchase of these Chevrolet Suburban SUVS under the Cooperative Purchase Provision of the County of Los Angeles, Purchase Order No. 31088048 ("Los Angeles Contract"); and

WHEREAS, Resolution No. RES-07-0039 authorizes the City Purchasing Agent to purchase these Chevrolet Suburban SUVs from Contractor by virtue of the Los Angeles Contract;

NOW, THEREFORE, in consideration of the terms and conditions contained in this Agreement, the parties agree as follows:

- The Los Angeles Contract with Contractor is incorporated by this reference as if fully set forth, and the same terms and conditions contained in the Los Angeles Contract shall be applicable here except as follows:
- a. Wherever the Los Angeles Contract refers to the County of Los Angeles, it shall be deemed to refer to the City of Long Beach;
- Contractor shall sell, furnish and deliver to the City equipment of substantially the same type and kind purchased by the County of Los Angeles and on the

same terms and conditions offered to the County of Los Angeles, except as modified by Exhibit "A" attached to and incorporated in this Agreement, for an amount not to exceed \$81,040,46 including tax, for a period extending until the warranty on the Chevrolet To the extent that the Los Angeles Contract and this Suburban SUVs expires. Agreement are inconsistent, the following priority shall govern: (1) this Agreement and (2) the Los Angeles Contract.

- c. Payment for the equipment purchased from Contractor by the City shall be made by the City on delivery to and acceptance of the equipment by the City and submittal of an invoice to the City. Payment is due thirty (30) days after the date of the invoice.
 - d. All warranties shall accrue to the City of Long Beach.
- e. The parties may, by mutual agreement, amend this Agreement with the approval of the City's City Council.
- 2. Neither this Agreement nor any money that becomes due to Contractor under this Agreement may be assigned by Contractor without the prior written consent of the City Manager or his designee.
- 3. Any notice given under this Agreement shall be in writing and personally delivered or deposited in the U.S. Postal Service, return receipt, and shall be delivered or mailed to Contractor at the relevant address first stated above, and to the City at 333 West Ocean Boulevard, Long Beach, California 90802 Attn: City Manager. Notice shall be deemed given three days after deposit in the mail.
- 4. The terms appearing on the Los Angeles Contract are incorporated in this Agreement. Contractor is called "Vendor" in the Los Angeles Contract.
- 5. Contractor shall cooperate with the City in all matters relating to selfaccrual of use tax. Contractor shall contact the City Treasurer for additional information regarding self-accrual.
- 6. This Agreement and all documents which are incorporated by reference in this Agreement constitute the entire understanding between the parties and supersede

all other Agreements, oral or written, with respect to the subject matter of this Agreement. If there is any legal proceeding between the parties to enforce or interpret this Agreement, or to protect or establish any rights or remedies, the prevailing party shall be entitled to its costs and expenses, including reasonable attorney's fees.
