3 A RESOLUTION OF THE CITY COUNCIL OF THE
4 CITY OF LONG BEACH AUTHORIZING THE CITY
5 MANAGER TO EXECUTE A CONTRACT WITH SIMPLER
6 SYSTEMS, INC., WITHOUT ADVERTISING FOR BIDS,
7 FOR FINANCIAL SOFTWARE LICENSING AND RELATED
8 SERVICES IN AN AMOUNT NOT TO EXCEED \$150,000.00

10 WHEREAS, Simpler Solutions, Inc. is the sole provider of the EZ-FAMIS
11 software utilized by the City for financial management operations; and

12 WHEREAS, the City has invested considerable resources with Simpler
13 Solutions in developing the infrastructure for the City's EZ-FAMIS accounting software;
14 and

15 WHEREAS, in the development and maintenance of said software, City
16 occasionally requires the services of the vendor for updates, licensing, repairs and
17 enhancements; and

18 WHEREAS, as a result, no useful purpose would be served by advertising
19 for bids and to do so would constitute an idle and useless act and an unnecessary
20 expenditure of public funds;

21 NOW, THEREFORE, the City Council of the City of Long Beach resolves as
22 follows:

23 Section 1. The City Manager is hereby authorized to enter a contract
24 with Simpler Solutions, Inc. for annual maintenance and consulting services for the City's
25 EZ-FAMIS system in an amount not to exceed \$150,000.00 without advertising for bids.

26 Section 2. This resolution shall take effect immediately upon its adoption
27 by the City Council, and the City Clerk shall certify the vote adopting this resolution.
