

RESOLUTION NO. C-28397

A RESOLUTION OF THE CITY COUNCIL OF THE  
CITY OF LONG BEACH AUTHORIZING THE CITY  
MANAGER TO PURCHASE CELLULAR TELEPHONE  
SERVICE THROUGH THE CONTRACT BETWEEN THE  
WESTERN STATES CONTRACTING ALLIANCE AND  
NEXTEL OF CALIFORNIA, INC.

WHEREAS, the Charter of the City of Long Beach, Section 1802, permits  
the City to purchase services, supplies, materials, equipment, and labor with other  
government agencies by purchasing under their contracts on a voluntary and selective  
basis when authorized by resolution; and

WHEREAS, the City of Long Beach desires to purchase cellular  
telephone service from Nextel of California, Inc.; and

WHEREAS, the Western States Contracting Alliance ("Alliance") has a  
contract for the purchase of Verizon cellular telephone service known as Contract No.  
12-00115 ("Alliance Contract"); and

WHEREAS, City's participation in the Alliance Contract will facilitate  
acquisition of the cellular telephone service as well as provide considerable cost  
benefits to the City; and

WHEREAS, if the City had to go to formal bid rather than participate in the  
Alliance Contract considerably more funds would be required;

NOW, THEREFORE, the City of Long Beach resolves as follows:

Section 1. The above recitals are true and correct and are incorporated  
herein by this reference.

Sec. 2. The City Manager of the City of Long Beach is hereby authorized  
to enter an agreement with Nextel of California, Inc., Inc. for the purchase of cellular

2 Contract. The purchase by the City of Long Beach shall be on the same terms and  
3 conditions afforded to the Alliance, in an amount not to exceed \$624,696.00 annually.

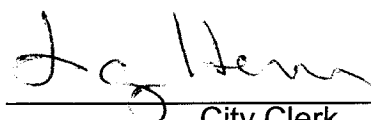
4 Sec. 3. This resolution shall take effect immediately on its adoption by the
