3                   THIS FIRST AMENDMENT TO CONTRACT NO. 34725 is entered into, in  
4                   duplicate, effective as of December 19, 2018, for reference purposes only, pursuant to a  
5                   minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6                   July 18, 2017, by and between 247 CLASSROOM, LLC DBA AMERICAN HERITAGE  
7                   COLLEGE, a California limited liability company with offices located at 765 The City Drive,  
8                   Unit 380, Orange, California 92868 ("Contractor"), and the CITY OF LONG BEACH, a  
9                   municipal corporation ("City") and administering entity for Pacific Gateway Workforce  
10                  Investment Network.

11                   WHEREAS, City and Contractor (the "Parties") entered into Contract No.  
12 34725 (the "Contract") whereby Contractor agreed to provide vocational skills training and  
13 educational support in various sectors to Pacific Gateway participants; and

14 WHEREAS, the Parties desire to extend the term one (1) additional one-year  
15 period and add \$55,000 to the contract;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and  
17 conditions herein contained, the Parties agree as follows:

18 1. Section 2.A. of the Contract is hereby amended to read as follows:.

19                   “A.     The term of this Contract (“Term”) shall be deemed to have  
20                   commenced as of December 1, 2016, and unless sooner terminated pursuant to the  
21                   provisions hereof, shall terminate on November 30, 2019.   Either of the parties  
22                   hereto shall have the right to terminate this Contract in its entirety at any time during  
23                   the Term for any or no reason whatsoever by giving fifteen (15) days prior written  
24                   notice of termination to the other party.  City shall have the additional right to cancel  
25                   any part of this Contract at any time during the Term for any reason whatsoever by  
26                   giving fifteen (15) days’ notice of such cancellation to the Contractor.”

27 2. Section 5.A. of the Contract is hereby amended to read as follows:


28 "A. The total amount which shall be payable by City to Contractor


1 for Contractor's allowable services during the Term shall not exceed Three Hundred  
2 Thousand Dollars (\$300,000)."

3. Except as expressly modified herein, all of the terms and conditions  
4 contained in Contract No. 34725 are ratified and confirmed and shall remain in full force  
5 and effect.


