

1 FIRST AMENDMENT TO AGREEMENT NO. 30851

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 30851 is made and  
4 entered, in duplicate, as of February 17, 2010 for reference purposes only, pursuant to a  
5 minute order adopted by the City Council of the City of Long Beach at its meeting held on  
6 February 16, 2010, by and between HNTB CORPORATION, a Delaware corporation  
7 ("Consultant"), with a place of business at 715 Kirk Drive, Kansas City, Missouri 64105,  
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the parties entered Agreement No. 30851 whereby Consultant  
10 agreed to perform As-Needed Airport Planning, Engineering, and Architectural Consulting  
11 Services ("Project"); and

12 WHEREAS, the parties desire to extend the term and increase the  
13 Agreement amount by \$1,500,000;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
15 the Agreement and in this First Amendment, the parties agree as follows:

16 1. Section 1.A. of Agreement No. 30851 is hereby amended to read as  
17 follows:

18 "1. SCOPE OF WORK OR SERVICES.

19 A. Consultant shall furnish specialized services more particularly  
20 described in Exhibit "A", attached to this Agreement and incorporated by this reference,  
21 in accordance with the standards of the profession, and City shall pay for these services  
22 in the manner described below, not to exceed Two Million Five Hundred Thousand  
23 Dollars (\$2,500,000.00), at the rates or charges shown in Exhibit "A".

24 2. Section 2 of Agreement No. 30851 is hereby amended to read as  
25 follows:

26 "2. TERM. The term of this Agreement shall commence at midnight on  
27 August 1, 2008, and shall terminate at 11:59 p.m. on July 31, 2014, unless sooner  
28 terminated as provided in this Agreement, or unless the services or the Project is

1 completed sooner.”

2 3. Except as expressly amended in this First Amendment, all terms and  
3 conditions in Agreement No. 30851 are ratified and confirmed and shall remain in full  
4 force and effect.
