Recommendation to declare ordinance amending Chapter 16.08 of the Long Beach Municipal Code by amending Sections 16.08.090, 16.08.130, 16.08.140, 16.08.261, 16.08.263, 16.08.265, 16.08.266, 16.08.340, 16.08.350, 16.08.460, 16.08.470, 16.08.551, 16.08.570, 16.08.581, 16.08.680, 16.08.900, 16.08.970; by adding Sections 16.08.021, 16.08.022, 16.08.023, 16.08.024, 16.08.025, 16.08.026, 16.08.101, 16.08.211, 16.08.221, 16.08.222, 16.08.223, 16.08.268, 16.08.501, 16.08.502, 16.08.503, 16.08.504; and by repealing Sections 16.08.260 and 16.08.262, all relating to Marinas read the first time and laid over the next regular meeting of the City Council for final reading.

Chapter 16.08 MARINAS

16.08.021 Alamitos Bay Marina Long Dock North.

“Alamitos Bay Marina Long Dock North” means that dock located at a point approximately eighty feet (80’) west of the building known as 190 N. Marina Drive in the Alamitos Bay entry channel, and running in a north south direction for a distance of approximately three hundred and ninety feet (390’).

16.08.022 Alamitos Bay Marina Long Dock South.

“Alamitos Bay Marina Long Dock South” means that dock located in the Alamitos Bay entry channel, at a point approximately eighty feet (80’) west of the building known as 110 N. Marina Drive, and running in a north south direction for a distance of approximately three hundred and fifty-five feet (355’).

16.08.023 Alamitos Bay Marina Slip 59.

“Alamitos Bay Marina Slip 59” means that first, twenty foot (20’) slip located northeasterly of Gangway 5, at a point approximately twenty feet (20’) north of the building known as 215 North Marina Drive, in Alamitos Bay Marina.

16.08.024 Alamitos Bay Marina Slip 585.

“Alamitos Bay Marina Slip 585” means that first, twenty foot slip located northeasterly of Gangway 18, at a point approximately one hundred feet (100’) west of the building known as 241 North

1 **Marina Drive, in Alamitos Bay Marina.**

3 **16.08.025 Alamitos Bay Marina Slip 664.**

4 **“Alamitos Bay Marina Slip 664” means that second, twenty**
5 **foot (20’) slip located west of Gangway 19, at a point approximately**
6 **eighty feet (80’) west of the building known as 241 North Marina**
7 **Drive, in Alamitos Bay Marina.**

8

9 **16.08.026 Alamitos Bay Marina Slip 666.**

10 **“Alamitos Bay Marina Slip 666” means that first, twenty foot**
11 **(20’) slip located west of Gangway 19, at a point approximately eighty**
12 **feet (80’) west of the building known as 241 North Marina Drive, in**
13 **Alamitos Bay Marina.**

14

15 **16.08.090 ~~Downtown~~ Shoreline Marina.**

16 **“~~Downtown~~ Shoreline Marina” means those portions of the**
17 **tidelands area bounded as follows:**

18 **Beginning at the intersection of Shoreline Drive and Linden**
19 **Avenue; thence southeast along the centerline extension of Linden**
20 **Avenue to the intersection of a line parallel with and two hundred twenty**
21 **feet (220’) northwesterly from the shoreline enrockment reference line to**
22 **be known as the point of beginning; thence southwesterly along last said**
23 **line to the intersection of a line parallel with and two hundred eighty-five**
24 **feet (285’) easterly of the ~~Shoreline Harbor~~ **Rainbow Marina** Concrete**
25 **Bulkhead; thence southerly along last said line to the intersection of a line**
26 **parallel with and eighty feet (80’) northerly from the shoreline enrockment**
27 **reference line; thence southwesterly along last said line to the intersection**
28 **of the northerly projection of the west enrockment reference line of the**

1 ~~Downtown~~ **Shoreline** Marina Mole; thence southeasterly along last said
2 line; thence northeasterly along the Mole southeasterly enrockment
3 reference line to the most easterly point of the ~~Downtown~~ Marina Mole;
4 thence northeast to the most westerly point of Oil Island Grissom; thence
5 northeasterly along the northwest portion of Oil Island Grissom to the most
6 northerly point in Oil Island Grissom; thence northeast to the intersection
7 of the east enrockment reference line and the most southerly point of the
8 ~~Downtown~~ **Shoreline** Marina East Jetty; thence northwest along said Jetty
9 east enrockment reference line to the intersection of a line parallel with
10 and two hundred twenty feet (220') northwesterly from the Shoreline
11 enrockment reference line; thence southwesterly along last said line to the
12 point of beginning.

13
14 **16.08.101 Harbormaster's Dock – Alamitos Bay Marina.**

15 "Harbormaster's Dock" means that one hundred forty-eight
16 foot (148') dock which runs along the northwesterly side of the
17 Harbor Master Building located at 205 N. Marina Drive in the Alamitos
18 Bay Marina area.

19
20 **16.08.130 Marina Basins.**

21 "Marina Basins" means those portions of the Long Beach Marina
22 Area designated as Marina Basins 1, 2, 3, 4, 5, 6, 7, 8 and Naples
23 Landing within the following described boundaries:

24 A. Beginning at the intersection of the northeasterly line of Marina
25 Drive with a line parallel with and fifty feet (50') northwesterly from the
26 centerline of Second Street; thence southwesterly along last said line to
27 the centerline of Appian Way; thence southeasterly and southerly along
28 last said line to the centerline of Savona Walk; thence southwesterly along

1 last said line to the southwesterly line of Appian Way Service Road;
2 thence southeasterly along last said line, and the southeasterly
3 prolongations thereof, to the Vista Del Golfo bulkhead line; thence
4 southwesterly in a direct line approximately one thousand feet (1,000') to
5 the most westerly point on the shoreline of the southwesterly mole of
6 Basin No. 1; thence southerly along said shoreline to the common
7 southeasterly boundary of the Long Beach Marina Area and the City of
8 Long Beach; thence northeasterly and northwesterly along said boundary
9 of the Long Beach Marina Area to the point of beginning; and

10 B. Beginning at the intersection of the centerline of the westerly
11 jetty of the Alamitos Bay Entrance Channel with the southeasterly
12 prolongation of the centerline of Ocean Boulevard; thence northwesterly
13 along said prolongation and the centerline of Ocean Boulevard, being the
14 boundary of the Long Beach Marina Area, to the southeasterly
15 prolongation of the vacated alley northeasterly of Block 18 of the Alamitos
16 Bay Tract; thence northwesterly along said prolongation and centerline to
17 the southwesterly prolongation of the northwesterly wall line of Basin No.
18 5; thence northeasterly along said prolongation and wall line to its
19 northeasterly terminus; thence at right angles, southeasterly two hundred
20 ten feet (210') , more or less, to the easterly wall line of Basin No. 5;
21 thence southerly along said easterly wall line and easterly shoreline of the
22 westerly jetty of the Alamitos Bay Entrance Channel to the southeasterly
23 prolongation of the centerline of Ocean Boulevard; thence northeasterly
24 along said prolongation to the point of beginning;

25 C. Beginning at the intersection of the northeast line of Marine
26 Stadium West and the northwest line of Los Cerritos Channel; thence
27 northeast along the northwest line of the Los Cerritos Channel to its
28 intersection with the centerline of Pacific Coast Highway; thence southeast

1 along said centerline of Pacific Coast Highway to its intersection with the
2 southeast bulkhead line of the Los Cerritos Channel; thence southwest
3 along said southeast bulkhead line of the Los Cerritos Channel and its
4 prolongation across the Marina Pacifica Entrance Channel to its
5 intersection with the northeast line of Marine Stadium West; thence
6 northwesterly along said northeast line of Marine Stadium East to the point
7 of beginning, which describes the Los Cerritos Channel area of Basin No.
8 6;

9 D. Beginning at the intersection of the southeast bulkhead line of
10 the Los Cerritos Channel and the southwest bulkhead line of the Marina
11 Pacifica Entrance Channel; thence southeast along said southwest Marina
12 Pacifica bulkhead line to a ninety (90) degree angle point in said bulkhead;
13 thence southwest along said bulkhead line to a bulkhead angle point, said
14 bulkhead angle point being the most westerly point of the Marina Pacifica
15 Entrance Channel; thence southeast along the bulkhead line to the
16 intersection of the line, measured at right angle, fifty feet (50') from the
17 bulkhead line of the Marina Pacifica Entrance Channel; thence northeast
18 along a line parallel to and fifty feet (50') out from, measured at right
19 angles, the northwest bulkhead line of the Marina Pacifica Entrance
20 Channel to an angle point; thence northwest along a line parallel to and
21 fifty feet (50') out from southwest bulkhead line of the Marina Pacifica
22 Entrance Channel to the intersection of the projected southeast bulkhead
23 line of the Los Cerritos Channel; thence southwest to the point of
24 beginning, which describes the Marina Pacifica Entrance Channel portion
25 of Basin No. 6;

26 E. Beginning at a point in the northeasterly line of Ocean Boulevard
27 91.30 feet northwesterly of the northwesterly line of 55th Place; thence
28 north 57° 51' West along said northeasterly line of Ocean Boulevard

1 150.00; thence North 32° 03' East 68.50 feet; thence north 28° 30' West
2 35.60 feet; thence North 32° 03' East 144.00 feet; thence South 57° 57'
3 East 212.00 feet; thence South 32° 03' West 144.00 feet; thence South
4 64° 43' West 57.43 feet; thence South 32° 03' West 37.65 feet to the point
5 of beginning;

6 **F. Beginning at the most southerly southeasterly corner of Lot**
7 **202 of Tract No. 32277, as shown on a map recorded in Book 892,**
8 **Pages 80-88, inclusive of Maps, in the office of the County Recorder**
9 **of said Los Angeles County; thence along the southerly line of said**
10 **Lot 202, South 64°04'40" West 571.33 feet to the beginning of a curve**
11 **concave northwesterly and having a radius of 700.00 feet; thence**
12 **southwesterly 128.78 feet along said curve, through a central angle**
13 **of 10°32'28" to the southwesterly corner of said Lot 202; thence**
14 **continuing southeasterly 25.27 feet along said curve and southerly**
15 **line of Lot 203 of said Tract No. 32277, through a central angle of**
16 **2°04'07" to the southwest corner of said Lot 203;**

17 **The northwesterly and southeasterly lines of said strip shall be**
18 **lengthened or shortened so as to terminate northeasterly at the**
19 **southwesterly line of Pacific Coast Highway and southwesterly at the**
20 **southeasterly prolongation of a line that is radial to the southwest**
21 **corner of said Lot 203, said radial line being "South 13°18'45" East".**

23 16.08.140 Marinas.

24 "Marinas" mean the water areas and public lands and
25 improvements thereon within the Long Beach Marina Area, Downtown
26 Shoreline Marina, and the ~~Shoreline Harbor~~ **Rainbow Marina, the**
27 **Rainbow Harbor** and any other marina owned, operated, or controlled by
28 the City.

16.08.211 Pierpoint Landing Guest Dock.

“Pierpoint Landing Guest Dock” means the dock that connects Dock 1b and 1c in the Rainbow Harbor.

16.08.221 Rainbow Marina.

“Rainbow Marina” means those portions of the tidelands area bounded as follows:

Beginning at the intersection of Shoreline Drive and Pine Avenue; thence southwest along the centerline extension of Pine Avenue to the intersection of the south curb of the most southerly line of Shoreline Drive service road to be known as the point of beginning; thence easterly of said curb and its extension to the intersection of a line parallel with and 285 feet easterly of the Rainbow Marina concrete bulkhead; thence southerly along last said line to the intersection of a line parallel with and eighty feet (80') northerly from the shoreline enrockment reference line; thence southwesterly along last said line to the intersection of the northerly projection of the west enrockment reference line of the Shoreline Marina Mole; thence southeasterly along last said line to the shore line enrockment reference line at its extension; thence northwesterly along last said line to the intersection of the west enrockment reference line of the entrance channel of the Rainbow Marina, thence northeasterly along last said line to its most northerly point; thence northwest to the point of beginning.

16.08.222 Rainbow Marina Dock 8.

Dock 8 means that dock located at a point approximately twenty-five feet (25') northwesterly of the building known as 401

16.08.223 Rainbow Harbor.

“Rainbow Harbor” means those portions of the tidelands area bounded as follows:

Beginning at the intersection of the southerly line of Ocean Boulevard, one hundred feet (100') wide, with the centerline of Pine Avenue (North), one hundred feet (100') wide, and said intersection having the coordinates North 4,027,618.60 and East 4,229,816.61 of Zone 7 of the California Coordinate System, NAD 27, as shown on Drawing No. E212, on file in the Office of the City Engineer of Long Beach; thence South 0°05'28" East 1851.54 feet along said centerline and its southerly prolongation; thence EAST 602.31 feet to the most northerly corner of the Shoreline Village Lease Area as described in a legal description on file in the Office of the City Engineer of Long Beach; thence SOUTH 82.71 feet along the lease line of said lease to a point, said point also being the intersection of the landward edges of the existing northerly and easterly concrete bulkheads, said point being the most Northeasterly corner of the Rainbow Marina as described in a legal description on file in said Office of the City Engineer; thence along the landward edge of the northerly bulkhead and the northeasterly line of said Rainbow Marina, North 68°02'55" West to the most northerly corner of said Rainbow Marina, said point being the True Point of Beginning of this description. 14 "Marina Park Long Dock" means that long dock located
15 approximately one hundred feet northwest of the northwest corner of the
16 Marina Park Lifeguard Station in Marina Park.

17
18 16.08.265 Gangway A--Downtown Shoreline Marina.

19 "Gangway A at the Downtown Shoreline Marina" means that
20 gangway, which runs northerly from the north side of the Harbor Master
21 Building located at 450 Shoreline Drive in the Downtown Shoreline Marina
22 area.

23
24 16.08.266 Queensway Dock 10.

25 "Queensway Dock 10" means that three hundred foot dock located
26 at a point approximately one hundred twenty-three feet west of the
27 building known as 160 East Shoreline Drive and running in a westerly
28 direction for one hundred fifty feet (150') and southerly for one hundred

1 fifty feet (150').

3 **16.08.268 Rainbow Harbor Esplanade.**

4 **“Rainbow Harbor Esplanade” means the walkways and all**
5 **public area surrounding Rainbow Marina and Rainbow Harbor.**
6

7 16.08.340 Power to arrest and prepare and issue and deliver written
8 notice to appear.

9 A. Those employees of the City holding the unclassified position of
10 manager of the marine bureau, harbor master, superintendent of marine
11 safety, and superintendent of marine patrol and those employees of the
12 City holding or temporarily performing the duties of the classified positions
13 of marine safety captain, ~~lieutenant of beach safety, lieutenant of rescue~~
14 ~~boats,~~ marine safety sergeant, marine safety officer, lifeguard, ~~marine~~
15 ~~inspector,~~ ~~marine~~ **marina supervisor, marina agent I, marina agent II,**
16 **security special services officer I, security special services officer II,**
17 **security special services officer III, security special services officer IV**
18 **and security officer III** ~~marine-aide~~ employed in the bureau **City** shall
19 have the duty of enforcing such laws, ordinances, rules and regulations as
20 the City council may direct by regulation enacted pursuant to Section
21 16.08.970 and such tariff items as the board of harbor commissioners may
22 direct pursuant to Port of Long Beach Tariff No. 4 or any revision or
23 replacement thereof.

24 B. Those employees of the City holding or temporarily performing
25 the duties of the classified non-career positions of **security special**
26 **services officer I and security special services officer II** shall have the
27 duty of enforcing such laws and ordinances as the City council may direct
28 by regulation enacted pursuant to Section 16.08.970.

1 C. The employees referred to in subsections A and B above are
2 authorized, pursuant to California Penal Code Section 836.5, to arrest
3 persons and to prepare, issue, and deliver to any such arrested person a
4 written notice to appear in court and to release such person from custody
5 upon receiving from such person his or her written promise to appear in
6 court for any violation or violations of any section or sections designated
7 by the City council in regulations enacted pursuant to Section 16.08.970.

8 D. Nothing in this section is intended to operate either in addition to
9 or in contravention of Part 2, Title 3, Chapter 4.5, of the California Penal
10 Code which expressly designates those persons who are classified as
11 peace officers. Further, nothing in this section is intended to or shall
12 operate to change or shall have the effect of changing the status of the
13 officers and employees authorized to act pursuant to this section from
14 public or miscellaneous officers and employees to individual peace
15 officers or safety members or classes of peace officers or safety members
16 for purposes of retirement, workmen's compensation or similar injury or
17 death benefits or any other employee benefit or benefits to which said
18 employee would not have been entitled as a public employee prior to the
19 adoption of this section.

20
21 16.08.350 Defacing public property.

22 No person shall willfully injure, disfigure, deface, paint, damage,
23 destroy, disturb, remove, or interfere with any buoy, float, sign, notice,
24 fence, barrier, dock, pier, structure, improvement, harbor facility or other
25 property owned, maintained, or controlled by the City or other
26 governmental authority or any other property installed and maintained
27 under permit from the director within the marinas, **Rainbow Harbor, the**
28 **Esplanade at Rainbow Harbor and approaches thereto.**

16.08.460 Fishing restrictions.

No person shall fish from the sidewalk, parkway, seawall or bulkhead in or adjacent to the following described areas:

A. Both sides of Rivo Alto Canal between Naples Canal and the southerly prolongation of the centerline of the Colonnade;

B. Both sides of Naples Canal between the westerly line of tract no. 500, a point approximately eighty feet (80') westerly of the prolongation of the westerly line of Geneva Walk, and the southerly prolongation of the centerline of the Colonnade;

C. The northerly side of Alamitos Bay beginning at the westerly terminus of Corso Di Napoli, being the westerly line of tract no. 500, thence easterly and northerly to Naples Canal;

D. The northerly side of Alamitos Bay beginning at Rivo Alto Canal, thence southerly and easterly along Corso Di Napoli and Vista Del Golfo and continuing along the various courses of the bulkhead line to the southeasterly prolongation of the southwesterly line of the Appian Way service road;

E. Both sides of Marina Drive Bridge across the San Gabriel River, except from platforms provided for the purpose of fishing;

F. ~~Downtown~~ Shoreline ~~M~~marina, except from the fishing piers attached to the westerly mole;

G. Rainbow Harbor and Rainbow marina, **including the rock jetty, with the exception of fishing piers;**

H. Commercial and public docks throughout Alamitos Bay;

I. Within the confines of the Golden Shore Marine Biological Reserve and the Jack Dunster Marine Biological Reserve.

J. Public walkway adjacent to Alamitos Bay Marina, basin 5.

16.08.470 Three mile per hour speed limit--Restricted areas.

No person shall operate any vessel in the following designated areas at a rate of speed in excess of three (3) miles per hour:

- A. Marina basins;
- B. Naples Canal;
- C. ~~Downtown~~ Shoreline marina;
- D. ~~Shoreline Harbor~~ **Rainbow** marina;
- E. Marina Pacifica Channel and basins;
- F. Spinnaker Cove Channel and basins,
- G. Rainbow Harbor.**

16.08.501 Automobiles on Rainbow Harbor Esplanade.

No person shall allow any automobile or other vehicle, unless authorized by the director, to enter or park upon the Rainbow Harbor Esplanade .

16.08.502 Bicycles on Rainbow Harbor Esplanade.

Bicycle riding on the Rainbow Harbor Esplanade is prohibited in excess of three (3) miles per hour between the hours of 10 a.m. and 10 p.m., except City employees in the performance of their duties.

16.08.503 Roller Skates, Roller Blades and Skate Boards on Rainbow Harbor Esplanade.

The riding of skate boards, roller skates or roller blades is prohibited on the Rainbow Harbor Esplanade.

1 **16.08.504 Commercial Activity on Rainbow Harbor Esplanade.**

2 **No person is allowed to sell, barter or peddle any good or**
3 **service on the Rainbow Harbor Esplanade unless permitted by the**
4 **Director.**

5
6 16.08.551 Temporary mooring areas for vessels.

7 Temporary mooring areas for vessels shall be those wharfs, piers,
8 moorings, gangways or docks within the marinas owned by the City that

The City Council of the City of Long Beach ordains as follows:

2 southerly along last said line to the intersection of a line parallel with and
3 eighty feet (80') northerly from the shoreline enrockment reference line;

13 thence southwest along said bulkhead line to a bulkhead angle point, said
14 bulkhead angle point being the most westerly point of the Marina Pacifica
15 Entrance Channel; thence southeast along the bulkhead line to the
16 intersection of the line, measured at right angle, fifty feet (50') from the
17 bulkhead line of the Marina Pacifica Entrance Channel; thence northeast
18 along a line parallel to and fifty feet (50') out from, measured at right
19 angles, the northwest bulkhead line of the Marina Pacifica Entrance

27 D. Nothing in this section is intended to operate either in addition to
28 or in contravention of Part 2, Title 3, Chapter 4.5, of the California Penal

3 operate to change or shall have the effect of changing the status of the
4 officers and employees authorized to act pursuant to this section from

23 surfboard, parasail device, paddleboard, or kite surfboard in the following
24 designated areas:

25 A. Shoreline Marina;

26 B. Rainbow Marina;

27 C. Rainbow Harbor;

28 D. The entrance channel of the Shoreline Marina, Rainbow Marina,

1 or Rainbow Harbor, or within three hundred feet (300') thereof;

2 E. The entrance channel to the Alamitos Bay marina or within five
3 hundred (500) yards thereof.

4 "Sailboard boat" means a surfboard with a detachable mast and
5 sail.

6 Section 15. Section 16.08.680 of the Long Beach Municipal Code is
7 amended to read as follows:

8 16.08.680 No watercraft.

9 No surfboard, paddleboard or board boat shall be allowed in
10 Shoreline Marina, Rainbow Marina or Rainbow Harbor unless authorized
11 in writing by the Director.

12 Section 16. Section 16.08.900 of the Long Beach Municipal Code is
13 amended to read as follows:

14 16.08.900 Required.

15 A. No person shall berth any vessel at any slip within the Marina
16 Basins, the Shoreline Marina, the Rainbow Marina or the Rainbow Harbor
17 without first obtaining a permit from the Director. Such permit, except for a
18 permit for a visiting vessel, shall include a declaration from the owner that
19 the Marina Basins or other marina is the situs for his or her vessel for
20 purposes of levying by the City. Every person who has been issued a
21 permit pursuant to this section shall pay to the City such fees and deposits
22 as are prescribed in regulations enacted pursuant to Section 16.08.970.

23 B. Any deposit made or required shall not be refunded in the event
24 the permit for occupancy is granted. It shall, however, be refunded, less
25 an administrative processing fee, in the event an application is withdrawn
26 prior to the issuance of such permit. Subject to the prior approval of the
27 City Council, a permit may be granted to the United States of America, the
28 state, the county, the City, or to any public agency thereof, to berth a

1 vessel within the marinas without the payment of a fee therefore.

2 Section 17. Section 16.08.970 of the Long Beach Municipal Code is
3 amended to read as follows:

4 16.08.970 Regulations establishment.

5 The City Council may adopt, repeal, amend and modify regulations
6 regarding the berthing of vessels and other activities and operations within
7 the marinas, harbors and mooring areas. Any and all fees or service
8 charges established pursuant to the provisions of this chapter shall be
9 enacted by resolution of the City Council. Upon adoption, repeal,
10 amendment or modification of the regulations by the City Council, the
11 regulation shall be filed in the office of the City Clerk and posted in a
12 conspicuous place or places within the marina. Any person who violates
13 any such regulation shall be subject to the penalties provided for in
14 Section 1.32.010 of this Code. As to any person who is a permittee under
15 the provisions of this Chapter, violation of any such regulation, in addition
16 to the penalties applicable to persons generally, shall be cause for
17 revocation and cancellation of the person's permit.

18 Section 18. Section 16.08.021 of the Long Beach Municipal Code is
19 hereby added to read as follows:

20 16.08.021 Alamitos Bay Marina Long Dock North.

21 "Alamitos Bay Marina Long Dock North" means that dock located
22 at a point approximately eighty feet (80') west of the building known as 190
23 N. Marina Drive in the Alamitos Bay entry channel, and running in a north
24 south direction for a distance of approximately three hundred and ninety
25 feet (390').

26 Section 19. Section 16.08.022 of the Long Beach Municipal Code is
27 hereby added to read as follows:

28 16.08.022 Alamitos Marina Long Dock South.

1 "Alamitos Bay Marina Long Dock South" means that dock located in
2 the Alamitos Bay entry channel, at a point approximately eighty feet (80')
3 west of the building known as 110 N. Marina Drive, and running in a north
4 south direction for a distance of approximately three hundred and fifty-five
5 feet (355').

6 Section 20. Section 16.08.023 of the Long Beach Municipal Code is
7 hereby added to read as follows:

8 16.08.023 Alamitos Bay Marina Slip 59.

9 "Alamitos Bay Marina Slip 59" means that first, twenty (20) foot slip
10 located northeasterly of Gangway 5, at a point approximately twenty feet
11 (20') north of the building known as 215 North Marina Drive, in Alamitos
12 Bay Marina.

13 Section 21. Section 16.08.024 of the Long Beach Municipal Code is
14 hereby added to read as follows:

15 16.08.024 Alamitos Bay Marina Slip 585.

16 "Alamitos Bay Marina Slip 585" means that first, twenty foot (20')
17 slip located northeasterly of Gangway 18, at a point approximately one
18 hundred feet (100') west of the building known as 241 North Marina Drive,
19 in Alamitos Bay Marina.

20 Section 22. Section 16.08.025 of the Long Beach Municipal Code is
21 hereby added to read as follows:

22 16.08.025 Alamitos Bay Marina Slip 664.

23 "Alamitos Bay Marina Slip 664" means that second, twenty foot
24 (20') slip located west of Gangway 19, at a point approximately eighty feet
25 (80') west of the building known as 241 North Marina Drive, in Alamitos
26 Bay Marina.

27 Section 23. Section 16.08.026 of the Long Beach Municipal Code is
28 hereby added to read as follows:

1 16.08.026 Alamitos Bay Marina Slip 666.

2 "Alamitos Bay Marina Slip 666" means that first, twenty foot (20')
3 slip located west of Gangway 19, at a point approximately eighty feet (80')
4 west of the building known as 241 North Marina Drive, in Alamitos Bay
5 Marina.

6 Section 24. Section 16.08.101 of the Long Beach Municipal Code is
7 hereby added to read as follows:

8 16.08.101 Harbormaster's Dock – Alamitos Bay Marina.

9 "Harbormaster's Dock" means that one hundred forty-eight foot
10 (148') dock which runs along the northwesterly side of the Harbor Master
11 Building located at 205 N. Marina Drive in the Alamitos Bay Marina area.

12 Section 25. Section 16.08.211 of the Long Beach Municipal Code is
13 hereby added to read as follows:

14 16.08.211 Pierpoint Landing Guest Dock.

15 "Pierpoint Landing Guest Dock" means the dock that connects
16 Dock 1b and 1c in the Rainbow Harbor.

17 Section 26. Section 16.08.221 of the Long Beach Municipal Code is
18 hereby added to read as follows:

19 16.08.221 Rainbow Marina.

20 "Rainbow Marina" means those portions of the tidelands area
21 bounded as follows:

22 Beginning at the intersection of Shoreline Drive and Pine Avenue;
23 thence southwest along the centerline extension of Pine Avenue to the
24 intersection of the south curb of the most southerly line of Shoreline Drive
25 service road to be known as the point of beginning; thence easterly of said
26 curb and its extension to the intersection of a line parallel with and two
27 hundred eighty-five feet (285') easterly of the Rainbow Marina concrete
28 bulkhead; thence southerly along last said line to the intersection of a line

1 parallel with and eighty feet (80') northerly from the shoreline enrockment
2 reference line; thence southwesterly along last said line to the intersection
3 of the northerly projection of the west enrockment reference line of the
4 Shoreline Marina Mole; thence southeasterly along last said line to the
5 shore line enrockment reference line at its extension; thence northwesterly
6 along last said line to the intersection of the west enrockment reference
7 line of the entrance channel of the Rainbow Marina, thence northeasterly
8 along last said line to its most northerly point; thence northwest to the
9 point of beginning.

10 Section 27. Section 16.08.222 of the Long Beach Municipal Code is
11 hereby added to read as follows:

12 16.08.222 Rainbow Marina Dock 8.

13 Dock 8 means that dock located at a point approximately twenty-
14 five feet (25') northwesterly of the building known as 401 Shoreline Drive,
15 and running in a northwesterly direction for a distance of approximately
16 one hundred ten feet (110').

17 Section 28. Section 16.08.223 of the Long Beach Municipal Code is
18 hereby added to read as follows:

19 16.08.223 Rainbow Harbor.

20 "Rainbow Harbor" means those portions of the tidelands area
21 bounded as follows: Beginning at the intersection of the southerly line of
22 Ocean Boulevard, one hundred feet (100') wide, with the centerline of
23 Pine Avenue (North), one hundred feet (100') wide, and said intersection
24 having the coordinates North 4,027,618.60 and East 4,229,816.61 of Zone
25 7 of the California Coordinate System, NAD 27, as shown on Drawing No.
26 E212, on file in the Office of the City Engineer of Long Beach; thence
27 South 0°05'28" East 1851.54 feet along said centerline and its southerly
28 prolongation; thence EAST 602.31 feet to the most northerly corner of the

1 Shoreline Village Lease Area as described in a legal description on file in
2 the Office of the City Engineer of Long Beach; thence SOUTH 82.71 feet
3 along the lease line of said lease to a point, said point also being the
4 intersection of the landward edges of the existing northerly and easterly
5 concrete bulkheads, said point being the most Northeasterly corner of the
6 Rainbow Marina as described in a legal description on file in said Office of
7 the City Engineer; thence along the landward edge of the northerly
8 bulkhead and the northeasterly line of said Rainbow Marina, North
9 $68^{\circ}02'55''$ West to the most northerly corner of said Rainbow Marina, said
10 point being the True Point of Beginning of this description. Thence leaving
11 said bulkhead line and along the westerly line of said Rainbow Marina,
12 South $19^{\circ}20'58''$ West 819.42; thence leaving said westerly line, South
13 $83^{\circ}11'31''$ West 420.31 feet to its intersection with the landward edge of
14 the existing easterly concrete bulkhead line, said point being the beginning
15 of a non-tangent curve concave Westerly and having a radius of 180.00
16 feet; a radial line through said beginning of curve bears South $13^{\circ}53'29''$
17 East; thence northeasterly, northerly and westerly 483.38 feet along said
18 curve and bulkhead line through a central angle of $153^{\circ}51'54''$; thence
19 along the landward edge of the southerly, westerly and northerly concrete
20 bulkhead lines through the following courses: North $83^{\circ}08'53''$ West
21 698.32 feet to the beginning of a non-tangent curve concave
22 southwesterly and having a radius of 81.67 feet; a radial line through said
23 beginning of curve bears North $86^{\circ}04'14''$ East; thence northwesterly and
24 westerly 128.25 feet through a central angle of $89^{\circ}58'49''$ to the beginning
25 of a non-tangent curve concave southeasterly and having a radius of
26 400.00 feet, a radial line through said beginning of curve bears South
27 $69^{\circ}06'27''$ West; thence northerly, northeasterly, easterly and
28 southeasterly 1144.86 feet along said curve through a central angle of

1 163°59'20" to the beginning of a non-tangent curve concave northeasterly
2 and having a radius of 81.67 feet, a radial line through said beginning of
3 curve bears North 59°34'22" West; thence southerly and southeasterly
4 180.18 feet through a central angle of 126°24'12" to the beginning of a
5 non-tangent curve concave northerly and having a radius of 284.51 feet; a
6 radial line through said beginning of curve bears South 48°45'50" West;
7 thence southeasterly, easterly and northeasterly 578.51 feet along said
8 curve through a central angle of 116°30'18"; thence North 22°15'32" East
9 28.21 feet to the beginning of a non-tangent curve concave southerly and
10 having a radius of 220.60 feet, a radial line through said beginning of
11 curve bears North 9°14'24" West; thence easterly 99.37 feet along said
12 curve through a central angle of 25°48'34" to the beginning of a non-
13 tangent curve concave northeasterly and having a radius of 40.00 feet, a
14 radial line through said beginning of curve bears South 87°13'25" West;
15 thence southeasterly, easterly and northeasterly 88.27 feet along said
16 curve through a central angle of 126°26'11"; thence South 70°38'51" East
17 53.27 feet to the True Point of Beginning.

18 Section 29. Section 16.08.268 of the Long Beach Municipal Code is
19 hereby added to read as follows:

20 16.08.268 Rainbow Harbor Esplanade.

21 "Rainbow Harbor Esplanade" means the walkways and all public
22 area surrounding Rainbow Marina and Rainbow Harbor.

23 Section 30. Section 16.08.501 of the Long Beach Municipal Code is
24 hereby added to read as follows:

25 16.08.501 Automobiles on Rainbow Harbor Esplanade.

26 No person shall allow any automobile or other vehicle, unless
27 authorized by the director, to enter or park upon the Rainbow Harbor
28 Esplanade .

1 Section 31. Section 16.08.502 of the Long Beach Municipal Code is
2 hereby added to read as follows:

3 16.08.502 Bicycles on Rainbow Harbor Esplanade.

4 Bicycle riding on the Rainbow Harbor Esplanade is prohibited in
5 excess of three (3) miles per hour between the hours of 10 a.m. and 10
6 p.m., except City employees in the performance of their duties.

7 Section 32. Section 16.08.503 of the Long Beach Municipal Code is
8 hereby added to read as follows:

9 16.08.503 Roller Skates, Roller Blades and Skate Boards on Rainbow
10 Harbor Esplanade.

11 The riding of skate boards, roller skates or roller blades is
12 prohibited on the Rainbow Harbor Esplanade.

13 Section 33. Section 16.08.504 of the Long Beach Municipal Code is
14 hereby added to read as follows:

15 16.08.504 Commercial Activity on Rainbow Harbor Esplanade.

16 No person is allowed to sell, barter or peddle any good or service
17 on the Rainbow Harbor Esplanade unless permitted by the Director.

18 Section 34. Section 16.08.260 of the Long Beach Municipal Code is
19 hereby repealed.

20 Section 35. Section 16.08.262 of the Long Beach Municipal Code is
21 hereby repealed.

22 Section 36. The City Clerk shall certify to the passage of this ordinance by
23 the City Council and cause it to be posted in three (3) conspicuous places in the City of
24 Long Beach, and it shall take effect on the thirty-first (31st) day after it is approved by the
25 Mayor.
