

FIRST AMENDMENT TO CONTRACT NO. 34495

3 THIS FIRST AMENDMENT TO CONTRACT NO. 34495 is made and
4 entered, in duplicate, as of December 6, 2017 for reference purposes only, pursuant to
5 Resolution No. RES-16-0124, adopted by the City Council of the City of Long Beach at its
6 meeting on December 13, 2016, by and between ARCHI.TEXTURE, LLC DBA CATALYST
7 OFFICE, a California limited liability company (“Contractor”), with a place of business at 4
8 Park Plaza, Suite 100, Irvine, California 92614, and the CITY OF LONG BEACH (“City”), a
9 municipal corporation.

10 WHEREAS, City desires to purchase Steelcase furniture with related
11 accessories and services to furnish four (4) floors of office space located at the Long Beach
12 Airport; and

13 WHEREAS, City did by Resolution No. RES-16-0124 determine that the
14 City's need to purchase Steelcase furniture with related accessories and services to furnish
15 four (4) floors of office space located at the Long Beach Airport could only be met by
16 Contractor: and

17 WHEREAS, due to delays and changes to the office space plans only a
18 portion of the authorized Contract amount was used; and

19 WHEREAS, City desires to extend the term to use the remaining Contract
20 amount;

21 NOW, THEREFORE, in consideration of the mutual terms and conditions
22 contained herein, the parties agree as follows:

23 1. Section 3 of Contract No. 34495 is hereby amended to read as follows:
24 “3. The term of this Contract shall commence on January 1, 2017, and
25 shall terminate at midnight on December 1, 2018 unless sooner terminated as provided
26 herein. The City may terminate this Contract by giving thirty (30) days prior notice of
27 termination to Contractor.”


28 2. Except as expressly modified herein, all of the terms and conditions


