1 FIRST AMENDMENT TO AGREEMENT NO. 33857

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 33857 is made and
4 entered, in duplicate, as of April 13, 2016, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on April 7, 2015,
6 by and between OMNI-MEANS, LTD., a Nevada corporation ("Consultant"), with a place
7 of business at 669 Pacific Street, Suite A, San Luis Obispo, California 93401, and the CITY
8 OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with as-needed traffic engineering, transportation planning and
11 related technical and professional services; and

12 WHEREAS, the parties entered Agreement No. 33857 whereby Consultant
13 agreed to provide these Services; and

14 WHEREAS, the parties desire to decrease the agreement amount by
15 \$150,000;

16 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
17 conditions in this Agreement, the parties agree as follows:

18 1. Section 1.A of Agreement No. 33857 is hereby amended to read as
19 follows:

20 "1. SCOPE OF WORK OR SERVICES.

21 A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay for
24 these services in the manner described below, not to exceed Two Hundred Fifty
25 Thousand Dollars (\$250,000), at the rates or charges shown in Exhibit "B".

26 2. Except as expressly modified herein, all of the terms and conditions
27 contained in Agreement No. 33857 are ratified and confirmed and shall remain in full force
28 and effect.
