

1 FOURTH AMENDMENT TO CONTRACT NO. 34024

3 THIS FOURTH AMENDMENT TO CONTRACT NO. 34024 is entered, in
4 duplicate, as of August 5, 2021, for reference purposes only, pursuant to a minute order
5 adopted by the City Council of the City of Long Beach at its meeting held on September
6 10, 2019, by and between CARDON SOLUTIONS, LLC, a Florida limited liability company
7 ("Contractor"), with a place of business at 304 Indian Trace, Suite 526, Weston, Florida
8 33326, and the CITY OF LONG BEACH ("City"), a municipal corporation.

9 WHEREAS, City and Contractor (the "Parties") entered into Contract No.
10 34024 (the "Contract") whereby Contractor agreed to provide technical and functional
11 maintenance support and development services for the City's suite of Financial Accounting
12 Management Information Systems (FAMIS) and Simpler Suite (EZ FAMIS) reporting; and

13 WHEREAS, the Parties entered into a First Amendment to the Contract to
14 extend the term to September 30, 2018 and increase the not-to-exceed amount; and

15 WHEREAS, the Parties entered into a Second Amendment to the Contract
16 to extend the term to September 30, 2019 and amend certain provisions; and

17 WHEREAS, the Parties entered into a Third Amendment to the Contract to
18 increase the annual not to exceed amount to \$462,911 and extend the term to September
19 30, 2021;

20 WHEREAS, the Parties desire to add the authorized annual amount of
21 \$462,911 and extend the term one (1) additional one-year period;

22 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
23 conditions herein contained, the Parties agree as follows:

24 1. Section 2.D of the Contract is hereby amended to read as follows:

25 "D. October 1, 2019 to September 30, 2022, an annual amount of Four
26 Hundred Sixty-Two Thousand Nine Hundred Eleven Dollars (\$462,911)."

27 2. Section 3 of the Contract is hereby amended to read as follows:

28 "3. The term of this Contract shall commence on October 1, 2015, and

1 shall terminate at midnight on September 30, 2022 unless sooner terminated as provided
2 herein. The term may be extended for two (2) additional one-year periods, at the discretion
3 of the City Manager. The City may terminate this Contract by giving thirty (30) days prior
4 notice of termination to Contractor."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Contract No. 34024 are ratified and confirmed and shall remain in full force
7 and effect.
