SECOND AMENDMENT TO AGREEMENT NO. 28885

THIS SECOND AMENDMENT TO AGREEMENT NO. 28885 is made and entered, in duplicate, as of August 15, 2006 for reference purposes only, pursuant to a minute order of the City Council of the City of Long Beach at its meeting on August 3, 2004, and a minute order of the City Council of the City of Los Alamitos at its meeting on 11, 2004, by and between the CITY OF LONG BEACH ("Long Beach" and the CITY OF LOS ALAMITOS ("Los Alamitos").

WHEREAS, the parties entered Agreement No. 28885 whereby Long Beach agreed to provide animal control services to Los Alamitos; and

WHEREAS, the Agreement contains a provision allowing the parties, by mutual agreement, to extend the term of the Agreement and the parties desire to do so;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Second Amendment, the parties agree as follows:

1. Section 1 of the Agreement is hereby amended in its entirety to read as follows:

"SECTION 1. <u>TERM</u>. The original term of this Agreement shall commence at 12:01 a.m. on July 1, 2004, and shall terminate at midnight on June 30, 2005, and the first extended term shall begin on July 1, 2005 and end at midnight on June 30, 2006, and the second extended term shall begin on July 1, 2006 and end at midnight on June 30, 2007, unless sooner terminated as provided below."

- 2. Section 4 is hereby amended by the addition of the following subsection "H" to read as follows:
- "H. During in the second extended term, in the event and to the extent that the total amount of any and all license fees retained by Long Beach does not equal or exceed Seventy-Eight Thousand One Hundred Eight Dollars (\$78,108) for the period from July 1, 2006 through June 30, 2007, then Los Alamitos shall pay to Long Beach the difference between the total amount of all license fees retained by Long Beach and

Seventy-Eight Thousand One Hundred Eight Dollars (\$78,108). Payment of the difference shall be made on or before July 31, 2007. In the event and to the extent that the total amount of all license fees retained by Long Beach exceeds Seventy-Eight Thousand One Hundred Eight Dollars (\$78,108) on June 30, 2007, then the excess shall be divided equally between Long Beach and Los Alamitos."

- 3. Section 4 is hereby amended by the addition of the following subsection "I" to read as follows:
- "I. In the event of termination of this Agreement pursuant to Section 7 or Section 9, Long Beach shall retain fees as compensation for services provided by Long Beach through the effective date of termination. In the event and to the extent that the total amount of any and all fees retained by Long Beach to the effective date of termination does not equal or exceed Six Thousand Five Hundred Nine Dollars (\$6,509.00) for each month that the Agreement has been in effect, then Los Alamitos shall pay to Long Beach the difference between the total fees to the effective date of termination and the dollar figure obtained by multiplying \$6,509.00 times the number of months that the Agreement was in effect prior to its early termination. A partial month shall be deemed a full month. Los Alamitos shall pay the difference within thirty (30) days after the effective date of termination. Long Beach shall pay any excess fees to Los Alamitos."
 - 4. Exhibit "A" is hereby replaced with Exhibit "A-1" effective October 1, 2006.
- 5. Except as expressly amended in this Second Amendment, all terms and conditions in Agreement No. 28885 are ratified and confirmed and shall remain in full force and effect.
