FIRST AMENDMENT TO AGREEMENT NO. 30226

THIS FIRST AMENDMENT is made and entered, in duplicate, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on January 18, 2011, by and between NUVIS, a California corporation, whose business address is 3151 Airway Avenue, Suite J-3, Costa Mesa, California 92626 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the City requires specialized services requiring unique skills to be performed in connection with As-Needed Landscape Architecture Services ("Project"); and

WHEREAS, City selected Consultant in accordance with City's administrative procedures and City ascertained that Consultant and its employees are qualified, licensed, if so required, and experienced in performing such specialized services; and

WHEREAS, the Parties executed Agreement No. 30226 on August 2, 2007 wherein Consultant agreed to provide City with as-needed Landscape Architecture Services; and

WHEREAS, the Parties now desire to revive Agreement No. 30226 and extend the term;

NOW, THEREFORE, in consideration of the mutual terms covenants, and conditions in this Agreement, the parties agree as follows:

1. Section 2 of Agreement No. 30226 is hereby amended in its entirety to read as follows:


"2. TERM. The term of this Agreement shall commence on December 19, 2006 and shall terminate on August 31, 2012, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly amended herein, all of the terms, covenants, and conditions of Agreement No. 30226, as amended, and to the extent not contrary to this First Amendment, shall remain in full force and effect.






