THIS FIRST AMENDMENT TO AGREEMENT NO. 29642 is made and entered, in duplicate, as of December 21, 2007 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting held on December 18, 2007, by and between DMJM + HARRIS, INC. a California corporation, with a place of business at 999 Town & Country Rd., Orange, California 92868 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 29642 whereby Consultant agreed to provide specialized services requiring unique skills to be performed in connection with As-Needed Engineering Services ("Project"); and

WHEREAS, the parties desire to increase the contract amount;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this First Amendment, the parties agree as follows:

1. Section 1.A. of Agreement No. 29642 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

A. Consultant shall furnish specialized services more particularly set forth in Exhibit "A", attached hereto and incorporated herein by this reference, in accordance with the standards of the profession, and City shall pay for said services in the manner described below, not to exceed \$3,000,000.00."

2. Except as expressly amended in this First Amendment, all terms and conditions in the Agreement are ratified and confirmed and shall remain in full force and effect.
