



# BELMONT SHORE

## Tree Care Project Proposal

### OVERVIEW & PURPOSE

The Conservation Corps of Long Beach (CCLB) proposes to water trees on and around of Belmont Shore, in order to ensure tree survivability and promote shade for the public and visitors to the Belmont Shore area.

### STANDARDS

The Conservation Corps of Long Beach (CCLB) proposes to water trees in areas around the area of Belmont Shore. Watering will be done for the duration of three times a month for the first month at three times a month, the third month for two times a month and after that we will discuss process.

### EXECUTION

If requested, the Conservation Corps of Long Beach will provide tree maintenance services (deep watering, weeding, etc...) at the cost of \$5.00 per tree per visit. Maintenance services include deep watering each tree with 15 gallons of water utilizing CCLB's watering trailer and the removal weeds, trash, and debris from tree wells. On an as needed basis CCLB will also repair/replace tree ties and stakes. On a monthly basis CCLB will provide a monthly maintenance log delineating date/s of visit and all maintenance issues will be noted.

CCLB recommends the following maintenance schedule:

- April: Once a month
- May & June: 2 visits per month (watering every other week)
- July, August, & September: 4 visits per month (watering every week)

### SPECIAL INSTRUCTIONS

Service all tree wells, stakes, and tree ties when watering. Ensure tree wells are free of weeds and debris.
