- 8. The locations identified on Exhibit "B", which is attached hereto and incorporated herein by this reference, are hereby added to the Contract.



Paid Sick Leave Cost Analysis-Long Beach

- Average hourly rate- $\$11.80 \times 25\%$ burden= $\$14.15/\text{hr}$
- 3 days paid sick leave= $24\text{hrs} \times \$14.15 = \$354.00/\text{man}$
- $\$354 \times 13\text{men} = \$4,602.00/\text{yr}$
- $\$4,602/12\text{ months} = \$384.00/\text{mo}$
