

1 FIFTH AMENDMENT TO AGREEMENT NO. 34706

3 THIS FIFTH AMENDMENT TO AGREEMENT NO. 34706 is made and
4 entered, in duplicate, as of November 25, 2019, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 March 5, 2019, by and between JASON ADDISON SMITH CONSULTING SERVICES,
7 INC. DBA JAS PACIFIC, a California corporation ("Consultant"), with a place of business
8 at 201 North Euclid Avenue, Suite A, Upland, California 91786, and the CITY OF LONG
9 BEACH, a municipal corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 34706 (the "Agreement") whereby Consultant agreed to provide as-needed plan review
12 and inspection services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 add \$34,500 for a total not to exceed amount of \$114,500; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to add \$150,000 for a total not to exceed amount of \$264,500; and

17 WHEREAS, the Parties entered into a Third Amendment to the Agreement
18 to add \$166,300 for a total not to exceed amount of \$430,800; and

19 WHEREAS, the Parties entered into a Fourth Amendment to the Agreement
20 to add \$181,100 for a total not to exceed amount of \$611,900 and extend the term to July
21 31, 2020; and

22 WHEREAS, the Parties desire to add \$55,100 to the Agreement for a total
23 not to exceed amount of \$667,000;

24 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
25 conditions herein contained, the Parties agree as follows:

26 1. Section 1.A. of the Agreement is hereby amended to read as follows:

27 "A. Consultant shall furnish specialized services more particularly
28 described in Exhibit "A", attached to this Agreement and incorporated by this

reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Six Hundred Sixty-Seven Thousand Dollars (\$667,000), at the rates or charges shown in Exhibit "B".

2. Except as expressly amended herein, all terms and conditions in Agreement No. 34706 are ratified and confirmed and shall remain in full force and effect.
