Commissioner Greenwood announced the following:

The Wrigley Area Neighborhood Alliance has a Right-of-Entry Permit to Cressa Park and a group entitled Stewards of Cressa Park has been formed that work to maintain the native habitat, exclusively California natives. The group is looking for college interns to help supplement the outreach efforts and keep the volunteers motivated. Wrigley has the highest number of lawn conversions in the City under the grant program because the residents have something local and sustainable. The project consisted of watering the plants the first year and then the natural rainfall did the rest.
