**SUBJECT:** Third Amendment to Agreement No. 27232 With the City of Seal Beach to Provide Maintenance, Repair, and Collection Services for Parking Meters by the City of Long Beach (Citywide)

### DISCUSSION

In 1999, the City of Seal Beach installed 76 parking meters in three parking lots in their downtown business area. At that time, the City Council of Seal Beach requested the City of Long Beach to provide maintenance, repair and collection services for the parking meters. On January 19, 1999 the City Council authorized the City Manager to execute an agreement with the City of Seal Beach. Since that time the City of Long Beach has provided parking meter maintenance services for the City of Seal Beach.

The City of Seal Beach has now requested that the agreement be extended for three years. The agreement allows either party to terminate the agreement, with or without cause, by giving 60 days' written notice.

This item was reviewed by Senior Deputy City Attorney Donna Gwin and Budget Management Officer David Wodynski on August 25, 2004.

### TIMING CONSIDERATIONS

City Council action on this item is requested on September 7, 2004, as the current agreement expired January 31, 2004.

### FISCAL IMPACT

The City will receive \$12,000 in revenue for its services annually. This revenue is budgeted in the General Fund (GP) in the Department of Public Works (PW).


