Dear Mr. Cravens:

Please be advised that the Long Beach City Council, at its meeting held Tuesday, November 17, 2009, received and filed the subject application with a request to modify condition #1 to read as follows:

Sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 10:00 a.m. and 10:00 p.m. each day of the week.

On October 23, 2009, El Sauz Family Restaurant Inc. applied for a Person-to-Person transfer of Alcoholic Beverage Control License #483914. Pursuant to Business and Professions Code § 23800 (e), the Long Beach City Council is requesting a condition modification to the above listed application. On February 3, 2009, the Long Beach City Council revoked the business license held by Guadalupe Perez, dba, Mariscos Brite Spot, located at 1616 East Anaheim Street. The revocation was based on numerous alcohol related violations that created a nuisance at the above premises.

Please see attached Request for Revocation Memorandum from Anthony Batts, Chief of Police, and Recommendation After Hearing Letter from George Zugsmith, Hearing Officer. The Long Beach Police Department's Vice Investigations Section shall submit additional supporting evidence upon request.


