

1 FIRST AMENDMENT TO CONTRACT NO. 29707

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 29707 is made and
4 entered, in duplicate, as of June 27, 2007 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 13, 2006, by and between TAJANN CORPORATION, a California corporation, with
7 a place of business at 321 South Lilac Court, Anaheim Hills, California 92808
8 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, the City requires specialized services requiring unique skills to
10 be performed in connection with As-Needed Scanning Services ("Project"); and

11 WHEREAS, City has selected Consultant in accordance with City's
12 administrative procedures and City has determined that Consultant and its employees
13 are qualified, licensed, if so required, and experienced in performing these specialized
14 services; and

15 WHEREAS, City desires to have Consultant perform these specialized
16 services, and Consultant is willing and able to do so on the terms and conditions in this
17 Agreement; and

18 WHEREAS, the parties desire to extend the term of the Contract;

19 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
20 conditions in this Agreement, the parties agree as follows:

21 1. Section 2 of Contract No. 29707 is hereby amended in its entirety to
22 read as follows:

23 "2. TERM. The term of this Agreement shall commence at midnight on
24 August 1, 2006, and shall terminate at 11:59 p.m. on July 31, 2008, unless sooner
25 terminated as provided in this Agreement, or unless the services or the Project is
26 completed sooner."

27 2. Except as expressly amended herein, all terms and conditions in
28 Contract No. 29707 are ratified and confirmed and shall remain in full force and effect.
