Dear Mayor Garcia, Vice Mayor Andrews and Councilmembers:

The City of Long Beach is blessed to have outstanding community leaders. One person who fits that description is our friend Bob Foster. We are writing to ask you to honor the legacy and contributions of Mayor Bob Foster. We represent a wide range of people from across Long Beach and California and we all agree that Mayor Foster's leadership to our state deserve recognition in his adopted hometown. We ask that you consider naming the new council chamber in the Long Beach Civic Center the **Bob Foster Civic Chamber** to honor his lifetime of service.

Mayor Bob Foster was elected as the 27th Mayor of Long Beach in June 2006 and overwhelmingly reelected to a second term in 2010. He led the City of Long Beach through the tumultuous period of the great recession, making hard decisions to help the city cope with significant funding reductions and to make the city fiscally stable in the long run. He helped forge a path forward on pension reform by collaborating with employee groups to protect their pensions while also reducing pension obligations for the City.

Mayor Foster also helped lead innovative public private partnerships like the George Deukmejian Courthouse and developed the process to build the new Long Beach Civic Center, which will open later this year. When the seismic deficiencies of the current City Hall were discovered, he worked with staff to conduct an RFI and RFP process to build a new City Hall, Main Library, and Lincoln Park by leveraging existing dollars and using private capital to deliver public facilities. The Civic Center project would not have happened without his leadership and vision.

Before being elected Mayor, Bob served as president of Southern California Edison and retired in 2006 after more than 20 years with the company. As an Edison executive, he led California's largest electric company through the 1999 energy crisis. During his tenure, Edison developed the largest renewable, clean energy program (solar, geothermal, biomass and wind) in the United States.

Mayor Foster began his career in public service as a staffer in the California State Senate and California Energy Commission where he established statewide energy efficiency standards that are still enforced today. He was appointed as the Environment Committee chair in 2008, elected to the Advisory Board in 2009 and the Board of Trustees in 2010 for the U.S. Conference of Mayors.

Mayor Foster also served on the Board of Governors for the California Independent Systems Operator (ISO) and as a trustee to the California State University System. The CSU System saw impressive gains in student achievement and growth during his time on the Board.

Mayor Foster is a graduate of San Jose State University in public administration and received an Honorary Doctorate in recognition of his significant contributions.

Our specific request is that the Council forward this letter to the Council's Housing and Neighborhoods Committee, as well as the Harbor Commission, for consideration. Few Californians can match Mayor Foster's achievements or the

breadth and depth of his service. We think naming the new chamber the **Bob Foster Civic Chamber** is a fitting tribute to his lifetime of service.
