3 A RESOLUTION OF THE CITY COUNCIL OF THE  
4 CITY OF LONG BEACH APPROVING THE APPLICATION  
5 AND CONTRACT WITH THE CALIFORNIA DEPARTMENT  
6 OF ALCOHOLIC BEVERAGE CONTROL FOR GRANT  
7 FUNDING IN THE AMOUNT OF \$100,000

9 WHEREAS, THE CITY OF LONG BEACH desires to undertake a certain  
10 project designated as "ABC Investigations" to be funded in part from \$100,000 in funds  
11 made available through the 2018 Grant Assistance Program administered by the  
12 Department of Alcoholic Beverage Control (hereafter referred to as ABC);

13 NOW, THEREFORE, the City Council of the City of Long Beach resolves as  
14 follows:

15 Section 1. That the City Manager of the City of Long Beach is authorized  
16 to execute on behalf of the City Council a Contract, including any extensions or  
17 amendments thereof and any subsequent contract with the State in relation thereto.

18 Section 2. IT IS AGREED that any liability arising out of the performance  
19 of this contract, including civil court actions for damages, shall be the responsibility of the  
20 grant recipient and the authorizing agency. The State of California and ABC disclaim  
21 responsibility for any such liability.

22 Section 3. BE IT FURTHER RESOLVED that grant funds received  
23 hereunder shall not be used to supplant expenditures controlled by this body.

24 Section 4. IT IS ALSO AGREED that this award is not subject to local  
25 hiring freezes.

26 Section 5. This resolution shall take effect immediately upon its adoption  
27 by the City Council, and the City Clerk shall certify the vote adopting this resolution.


