1 THIRD AMENDMENT TO AGREEMENT NO. 33799

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 33799 is made and
4 entered, in duplicate, as of November 28, 2016, for reference purposes only, pursuant to
5 a minute order adopted by the City Council of the City of Long Beach at its meeting on
6 September 8, 2015, by and between TAIT ENVIRONMENTAL SERVICES, INC., a
7 California corporation ("Consultant"), with a place of business at 701 N. Parkcenter Drive,
8 Santa Ana, California, 92705, and the CITY OF LONG BEACH, a municipal corporation
9 ("City").

10 WHEREAS, the City requires specialized services requiring unique skills to
11 be performed in connection with Underground Storage Tank (UST) consulting and project
12 management services; and

13 WHEREAS, the parties entered Agreement No. 33799 whereby Consultant
14 agreed to provide these services; and

15 WHEREAS, the parties desire to extend the term and add the annual
16 amount of \$240,000 for a total not to exceed contract amount of \$906,760;

17 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
18 conditions herein contained, the parties agree as follows:

19 1. Section 1.A. of Agreement No. 33799 is hereby amended to read as
20 follows:

21 "A. Consultant shall furnish specialized services more particularly
22 described in Exhibit "A", attached to this Agreement and incorporated by this
23 reference, in accordance with the standards of the profession, and City shall pay
24 for these services in the manner described below, not to exceed Nine Hundred Six
25 Thousand Seven Hundred Sixty Dollars (\$906,760), at the rates or charges shown
26 in Exhibit "B"."

27 2. Section 2. Of Agreement No. 33799 is hereby amended to read as
28 follows:

1 "2. TERM. The term of this Agreement shall commence at
2 midnight on January 1, 2015, and shall terminate at 11:59 p.m. on December 31, 2017,
3 unless sooner terminated as provided in this Agreement, or unless the services or the
4 Project is completed sooner."

5 3. Except as expressly modified herein, all of the terms and conditions
6 contained in Agreement No. 33799 are ratified and confirmed and shall remain in full
7 force and effect.
