SUBJECT: Approve Program Supplement to Administering Agency – State Agreement No. 07-5108(066) for the Improvement of Clark Avenue Between Pacific Coast Highway and Atherton Street (Districts 3 and 4)

DISCUSSION

A Program Supplement to the governing agreement between the City and Caltrans is needed to formalize federal funding participation and obtain reimbursement for the rehabilitation of the pavement on Clark Avenue, between Pacific Coast Highway and Atherton Street. The rehabilitation work consisted of replacing damaged curbs and gutters, cold milling, resurfacing the pavement and installing new pavement markings. All work was completed on June 28, 2004.

This matter was reviewed by Deputy City Attorney Donna F. Gwin on August 26, 2004 and Budget Management Officer David Wodynski on September 1, 2004. In accordance with the California Environmental Quality Act, Categorical Exemption No. CEP-670-00 has been issued for this project.

TIMING CONSIDERATIONS

City Council action on this matter is requested on September 14, 2004, to execute the supplemental agreement in order to expedite receipt of funds obligated to this project.

FISCAL IMPACT

Sufficient funds were budgeted in Capital Improvement Project No. PW5061 in the Gasoline Tax Street Improvement Fund (SR 181), in the Department of Public Works (PW). Failure to execute a supplemental agreement will result in the loss of \$213,260 in federal reimbursement on this project.


