

ORDINANCE NO. C-

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LONG BEACH AMENDING THE LONG BEACH MUNICIPAL CODE BY AMENDING SECTION 10.04.50 (A), RELATING TO PARKING CONTROL

WHEREAS, Section 10.04.050 of the Long Beach Municipal Code grants Parking Control Checkers authority to issue notices of violation of the California Vehicle Code and ordinances of the City of Long Beach; and

WHEREAS, there is the occasional need to utilize City employees who hold classifications other than Parking Control Checker to issue notices of violation, such as injured employees who are temporarily unable to work in their assigned classifications; and

WHEREAS, the use of employees on medical restriction to perform such work is a recommended "best practice" implemented by the City's Workers Compensation program;

NOW, THEREFORE, the City Council of the City of Long Beach does hereby ordain as follows:

Section 1. Chapter 10.04.050 (A) of the Long Beach Municipal Code is hereby amended to read as follows:

10.04.050 Parking control checker authority.

A. Employees of the city employed in the classification of parking control checker, or such other classifications as approved by the appointing authority, are authorized and shall, in accordance with the applicable provisions of the Vehicle Code, have the duty to issue notices of violation of any statute of the state or any ordinance of the city or

2 parking of a vehicle.

4 Sec. 2. The City Clerk shall certify to the passage of this ordinance by the  
5 City Council of the City of Long Beach and cause the same to be posted in three  
6 conspicuous places in the City of Long Beach, and it shall take effect on the thirty-first  
7 day after it is approved by the Mayor.
