

FIRST AMENDMENT TO AGREEMENT NO. 30129

THIS FIRST AMENDMENT TO AGREEMENT NO. 30129 is made and entered, in duplicate, as of March 6, 2009 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 10, 2007 by and between THE RYTE PROFESSIONALS, a California corporation ("RYTE") located at 4141 Ball Road, Suite 517, Cypress, California 90630, and the CITY OF LONG BEACH, a municipal corporation ("Client").

WHEREAS, the parties entered Agreement No. 30129 in 2007, wherein "RYTE" agreed to provide professional computer services to Client; and

WHEREAS, the parties now desire to extend the term of said Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions herein, the parties agree as follows:

1. Section 1. of Agreement No. 30129 is hereby amended in its entirety to read as follows:

"1. AMOUNT: The amount of this Agreement shall not exceed \$200,000 during the term."

2. Section 2. of Agreement No. 30129 is hereby amended in its entirety to read as follows:

"2. TERM: The term of this Agreement shall commence at midnight on March 6, 2009, and shall terminate at 11:59 p.m. on March 1, 2010. This Agreement may be terminated by Client for cause or convenience on two weeks' prior notice without penalty or further obligation after Client has paid for services rendered through the date of termination."

3. Except as expressly amended herein, all of the terms, covenants, and conditions of Agreement No. 30129, as amended and to the extent not contrary to this First Amendment, shall remain unchanged and in full force and effect.
