In response to your request for a recommendation regarding the above named permit application for Entertainment With Dancing, the Police Department recommends **approval**, subject to the following fourteen (14) conditions of operation:

CONDITIONS OF OPERATION

- 1) The operation of the establishment shall be limited to those activities and elements expressly indicated on the permit application and approved by the City Council. Any change in the operation, which exceeds the conditions or hours of the approved permit, will require that a new permit application be submitted to the City Council for their review and approval.
- 2) Unless separately applied for, reviewed and approved, no adult entertainment, as defined by section 5.72.115(B) LBMC, shall be conducted on the permitted premises.
- 3) The permittee shall not convert the hall rental, or any portion thereof, into a public dance/night club. All entertainment activities shall be restricted to private social events or gatherings. The permittee shall not allow anyone to rent the hall for the purpose of holding a concert, dance, or disk jockey event, which is open to the public.
- 4) The permittee shall not allow any employee, agent, entertainer, client, valet, or delivery personnel to park any vehicle in any alley near the business at any time.
- 5) The permittee shall employ enough valet personnel to avoid customers having to illegally park their vehicles while waiting for the valet.
- 6) The permittee shall ensure that valet personnel immediately park any vehicle in an authorized and legal parking space. Vehicles are not to be illegally parked in a staging area to be parked at a later time.
- 7) The permittee or any client shall not hire promoters with the intent to advertise/promote or hold any entertainment activities consistent with nightclub entertainment.

- 8) The door(s) or windows shall be kept closed at all times during any entertainment activity described in your application, except in cases of emergency and to permit deliveries. Said door(s) are not to consist solely of a screen or ventilated security door.
- 9) No sound shall be audible from the exterior of the premises in any direction.
- 10) At the conclusion of each event, Fresh Ideas shall ensure that exiting patrons walk directly to their vehicles, and not loiter in the immediate area.
- 11) The permittee shall employ his/her own discretion in determining the level of security necessary to prevent violations of law and any other disturbances arising out of or in connection with business operations. Should the permittee's operations give rise to a substantial increase in complaints/calls for service, the permittee shall increase security as directed by the Chief of Police.
- 12) The permittee agrees to reimburse the City whenever excessive police services, as determined by the Chief of Police, are required as the result of any incident or nuisance arising out of or in connection with the permittee's operations.
- 13) If any noise, disturbance complaints, or trash left in the parking lot and surrounding area of the business can be attributed to the operation of said business, the Police Department can determine and impose requirements for security officer presence to routinely police and handle these problems.
- 14) The permittee shall maintain full compliance with all applicable laws, ABC laws, ordinances and stated conditions.


