THIRD AMENDMENT TO AGREEMENT NO. 28569

**28569**

THIS THIRD AMENDMENT TO AGREEMENT NO. 28569 is made and entered, in duplicate, as of April 11, 2006 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on August 24, 2004, by and between the CALIFORNIA STATE UNIVERSITY, LONG BEACH FOUNDATION, a California nonprofit corporation, on behalf of the CENTER FOR BEHAVIORAL RESEARCH AND SERVICES ("CBRS"), whose address is 6300 State University Drive, Long Beach, California 90815, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 28569 where CBRS agreed to provide HIV education and prevention services; and

WHEREAS, the parties desire to extend the term of the Agreement and to amend it in certain respects;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained in the Agreement and this Amendment, the parties agree as follows:

1. Section 1 of Agreement No. 28569 is amended in its entirety to read as follows:

"1. The original term of this Agreement shall commence at 12:01 a.m. on November 1, 2003, and shall terminate at 11:59 p.m. on October 31, 2004. The first extended term shall commence on November 1, 2004, and shall terminate at 11:59 p.m. on June 30, 2006. The second extended term shall commence at 12:01 a.m. on July 1, 2006 and shall terminate on June 30, 2007."

2. During the second extended term, City shall pay CBRS for such services an amount not to exceed One Hundred Fifty Three Thousand Dollars (\$153,000). Payment is contingent on receipt by the City of monies from the County of Los Angeles and on satisfactory performance, in City's sole opinion, of work by CBRS under this Agreement.
