

1 THIRD AMENDMENT TO AGREEMENT NO. 34689

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 34689 is made and
4 entered, in duplicate, as of July 12, 2018, for reference purposes only, pursuant to a minute
5 order adopted by the City Council of the City of Long Beach at its meeting on July 11, 2017,
6 by and between J. LEE ENGINEERING, INC., a California corporation ("Consultant"), with
7 a place of business at 430 South Garfield Avenue, Suite 301, Alhambra, California 91801,
8 and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City requires specialized services requiring unique skills to be
10 performed in connection with as-needed plan review and inspection services; and

11 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
12 34689 (the "Agreement") whereby Consultant agreed to provide these services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 increase the Agreement amount by \$40,000 for a total not to exceed Agreement amount
15 of \$75,000; and

16 WHEREAS, the Parties entered into a Second Amendment to the Agreement
17 to increase the Agreement amount by \$64,000 for a total not to exceed amount of
18 \$139,000; and

19 WHEREAS, the Parties desire to increase the Agreement amount by
20 \$106,400 for a total not to exceed amount of \$245,400;

21 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
22 conditions herein contained, the Parties agree as follows:

23 1. Section 1.A. of the Agreement is hereby amended to read as follows:

24 "A. Consultant shall furnish specialized services more particularly
25 described in Exhibit "A", attached to this Agreement and incorporated by this
26 reference, in accordance with the standards of the profession, and City shall pay for
27 these services in the manner described below, not to exceed Two Hundred Forty-
28 Five Thousand Four Hundred Dollars (\$245,400), at the rates or charges shown in
