

1 FIRST AMENDMENT TO AGREEMENT NO. 32952

3 THIS FIRST AMENDMENT TO AGREEMENT NO. 32952 is made and
4 entered, in duplicate, as of January 16, 2014 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 December 11, 2012, by and between GRAFFITI PROTECTIVE COATINGS, INC. a
7 California corporation ("Contractor"), with a place of business located at 419 N.
8 Larchmont Blvd., #264, Los Angeles, California 90004, and the CITY OF LONG BEACH
9 ("City"), a municipal corporation.

10 WHEREAS, the City desires to obtain graffiti removal services for sites
11 throughout the City of Long Beach; and

12 WHEREAS, the parties entered Agreement No. 32952 whereby Contractor
13 agreed to provide such services; and

14 WHEREAS, the parties desire to extend the term;

15 NOW, THEREFORE, in consideration of the mutual terms and conditions in
16 the Agreement and in this First Amendment, the parties agree as follows:

17 1. Section 1.B of Agreement No. 32952 is hereby amended to read as
18 follows:

19 "B. Contractor shall sell, furnish and deliver to the City graffiti
20 removal services of substantially the same type and kind purchased by the County
21 of Orange on the same terms and conditions offered to the County of Orange,
22 except as modified by Exhibit "B" attached hereto and incorporated in this
23 Agreement, for an amount not to exceed One Million Seventy-Seven Thousand
24 Six Hundred Dollars (\$1,077,600), annually. The term of this Agreement shall
25 commence at midnight on January 22, 2013, and shall terminate at 11:59 p.m. on
26 January 21, 2015. The parties have the option to extend the Agreement for one
27 additional one-year period. To the extent that the OC Contract and this
28 Agreement are inconsistent, the following priority shall govern: (1) this Agreement
