1 SIXTH AMENDMENT TO AGREEMENT NO. 35225

3 THIS SIXTH AMENDMENT TO AGREEMENT NO. 35225 is made and
4 entered, in duplicate, as of May 9, 2023, for reference purposes only, pursuant to minute
5 orders adopted by the City Council of the City of Long Beach at its meetings on March 5,
6 2019 and November 17, 2020, by and between MICHAEL BAKER INTERNATIONAL, INC.,
7 a Pennsylvania corporation ("Consultant"), with a place of business at 5 Hutton Centre
8 Drive, Suite 500, Santa Ana, California 92707, and the CITY OF LONG BEACH, a
9 municipal corporation ("City").

10 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
11 35225 (the "Agreement") whereby Consultant agreed to provide on-call environmental,
12 planning, affordable housing, and community engagement consultant services; and

13 WHEREAS, the Parties entered into a First Amendment to the Agreement to
14 add \$360,000 for a total not to exceed amount of \$485,000; and

15 WHEREAS, the Parties entered into a Second Amendment to the Agreement
16 to add \$555,000 for a total not to exceed amount of \$1,040,000 and extend the term to
17 March 5, 2022; and

18 WHEREAS, the Parties entered into a Third Amendment to the Agreement
19 to add \$300,000 for a total not to exceed amount of \$1,340,000; and

20 WHEREAS, the Parties entered into a Fourth Amendment to add \$500,000
21 to the Agreement for a total not to exceed amount of \$1,840,000 and extend the term to
22 March 5, 2023; and

23 WHEREAS, the Parties entered into a Fifth Amendment to add \$350,000 to
24 the Agreement for a total not to exceed amount of \$2,190,000 and extend the term one (1)
25 additional one-year period; and

26 WHEREAS, the Parties desire to add \$250,000 to the Agreement for a total
27 not to exceed amount of \$2,440,000;

28 NOW, THEREFORE, in consideration of the mutual terms, covenants, and

1 conditions herein contained, the Parties agree as follows:

2 1. Section 1.A. of the Agreement is hereby amended to read as follows:

3 "A. Consultant shall furnish specialized services more particularly
4 described in Exhibit "A", attached to this Agreement and incorporated by this
5 reference, in accordance with the standards of the profession, and City shall pay for
6 these services in the manner described below, not to exceed Two Million Four
7 Hundred Forty Thousand Dollars (\$2,440,000), at the rates or charges shown in
8 Exhibit "B".

9 2. Except as expressly modified herein, all of the terms and conditions
10 contained in Agreement No. 35225 are ratified and confirmed and shall remain in full force
11 and effect.


