WHEREAS, the parties desire to extend the term and add \$75,000 for a total not to exceed Contract amount of \$250,000;

NOW, THEREFORE, in consideration of the mutual terms and conditions in the Agreement and in this Second Amendment, the parties agree as follows:

1. Section 1.A. of Agreement No. 32867 is hereby amended to read as follows:

"1. SCOPE OF WORK OR SERVICES.

- A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Fifty Thousand Dollars (\$250,000), at the rates or charges shown in Exhibit "B"."
- 2. Section 2 of Agreement No. 32867 is hereby amended to read as follows:

"2. <u>TERM</u> . The term of the	is Agreement shall commence at midnight on
June 1, 2012, and shall terminate at 11:59 p.m. on May 31, 2015, unless sooner	
terminated as provided in this Agreement, or unless the services or the Project is	
completed sooner."	
3. Except as expressly amended in this Second Amendment, all terms	
and conditions in Agreement No. 32867 are ratified and confirmed and shall remain in full	
force and effect.
