FIRST AMENDMENT TO CONTRACT NO. 32275

THIS FIRST AMENDMENT TO CONTRACT NO. 32275 is made and entered, in duplicate, as of July 16, 2012, for reference purposes only, pursuant to Resolution No. RES-11-0081, adopted by the City Council of the City of Long Beach at its meeting on July 19, 2011, by and between HAAKER EQUIPMENT COMPANY ("Contractor"), a California corporation, located at 2070 N. White Avenue, La Verne, California 91750 and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the parties entered Contract No. 32275 whereby Contractor agreed to provide Elgin Pelican street sweeper parts; and

WHEREAS, the parties desire to extend the term of the Contract and add \$225,000 for a total not to exceed amount of \$450,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions in Contract No. 32275 and herein, the parties agree as follows:

- 1. Section 2 of Contract No. 32275 is hereby amended in its entirety to read as follows:
- "2. City shall pay Contractor in due course of payments, following receipt of an invoice from Contractor and upon acceptance from City for the street sweeper parts the prices shown in Exhibit "A", a sum not to exceed Four Hundred Fifty Thousand Dollars (\$450,000), including tax."
- 2. Section 3 of Contract No. 32275 is hereby amended in its entirety to read as follows:
- "3. The term of this Contract shall commence on August 1, 2011, and shall terminate at midnight on August 1, 2013 unless sooner terminated as provided herein. The City may terminate this Contract by giving thirty (30) days prior notice of termination to Contractor. The City has the option to renew this Contract for one (1) additional one (1) year period, at the discretion of the City Manager."
 - 3. Except as expressly modified herein, all of the terms and conditions
