1    FIRST AMENDMENT TO CONTRACT NO. 34073

3    THIS FIRST AMENDMENT TO CONTRACT NO. 34073 is made and  
4 entered, in duplicate, as of June 15, 2017, for reference purposes only, pursuant to  
5 Resolution No. RES-15-0127, adopted by the City Council of the City of Long Beach at its  
6 meeting on October 6, 2015, by and between LOS ANGELES TRUCK CENTERS, LLC, a  
7 California limited liability company ("Contractor"), with a place of business at 2429 S. Peck  
8 Road, Whittier, California 90601, and the CITY OF LONG BEACH ("City"), a municipal  
9 corporation.

10     WHEREAS, the Fleet Services Bureau requires replacement of equipment  
11 parts for their Sterling and Autocar units; and

12     WHEREAS, City and Contractor (the "Parties") entered into Contract No.  
13 34073 whereby Contractor agreed to furnish the replacement of equipment parts for the  
14 Sterling and Autocar units for the Fleet Services Bureau; and

15     WHEREAS, the Parties wish to exercise their first option to extend the term  
16 of the Contract;

17     NOW, THEREFORE, in consideration of the mutual terms and conditions  
18 contained herein, the parties agree as follows:

19     1.        Section 3 of Agreement No. 34073 is hereby amended to read as  
20 follows:

21     "3.        The term of this Contract shall be deemed to have commenced on  
22 August 1, 2017, and shall terminate at midnight on July 31, 2018 unless sooner  
23 terminated as provided in this Contract. The City shall have the option to extend the term  
24 of this Contract upon the same terms and conditions for one (1) additional one (1) year  
25 period upon advance written notice to Contractor."

26     2.        Except as expressly modified herein, all of the terms and conditions  
27 contained in Contract No. 34073 are ratified and confirmed and shall remain in full force  
28 and effect.
