FOURTH AMENDMENT TO AGREEMENT NO. 34109

THIS FOURTH AMENDMENT TO AGREEMENT NO. 34109 is made and entered, in duplicate, as of July 18, 2019, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on April 23, 2019, by and between PACIFICA SERVICES, INC., a California corporation ("Consultant"), with a place of business at 106 South Mentor Avenue, Pasadena, California 91106, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34109 (the "Agreement") whereby Consultant agreement to provide as-needed professional compliance monitoring services; and

WHEREAS, the Parties entered into a First Amendment to the Agreement to revise the rate schedule and update the name of the City Representative; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to revise the rate schedule; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to add \$200,000, revise the rate schedule and extend the term to November 14, 2019; and

WHEREAS, the Parties desire to add \$1,348,161 to the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

"A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed One Million Seven Hundred Eighty-Eight Thousand One Hundred Sixty-One Dollars (\$1,788,161), at the rates or charges shown in Exhibit "B"."

2. Except as expressly modified herein, all of the terms and conditions

1 contained in Agreement No. 34109 are ratified and confirmed and shall remain in full force  
2 and effect.
