

1 THIRD AMENDMENT TO AGREEMENT NO. 35785

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 35785 is made and
4 entered, in duplicate, as of October 25, 2022, for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 November 17, 2020, by and between PACIFICA SERVICES, INC., a California corporation
7 ("Consultant"), with a place of business at 106 S. Mentor Avenue, Suite 200, Pasadena,
8 California 91106, and the CITY OF LONG BEACH, a municipal corporation ("City").

9 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
10 35785 (the "Agreement") whereby Consultant agreed to provide labor compliance
11 monitoring services; and

12 WHEREAS, the Parties entered into a First Amendment to the Agreement to
13 increase the annual not to exceed amount by adding \$100,000 for a total not to exceed
14 amount of \$300,000; and

15 WHEREAS, the Parties entered into a Second Amendment to increase the
16 annual not to exceed amount by adding an additional \$100,000 for a total annual not to
17 exceed amount of \$400,000; and

18 WHEREAS, the Parties currently desire to extend the term of the Agreement
19 for one (1) additional one-year period and clarify the authorized not to exceed amount;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions herein contained, the Parties agree as follows:

22 1. Section 1.A. of the Agreement is hereby amended to read as follows.

23 "A. Consultant shall furnish specialized services more particularly
24 described in Exhibit "A", attached to this Agreement and incorporated by this
25 reference, in accordance with the standards of the profession, and City shall pay
26 for these services in the manner described below, in a total contract amount not to
27 exceed One Million One Hundred Thousand Dollars (\$1,100,000), at the rates or
28 charges shown in Exhibit "B"."
