WHEREAS, the parties entered Subcontract No. 30839 whereby Organization agreed to provide these services to the City; and

WHEREAS, the parties desire to amend this Subcontract to clarify that specified disbursements are amounts made to Organization on an annual basis;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Subcontract No. 30839 and herein, the parties agree as follows:

- 1. Section 4.B of Subcontract No. 30839 is amended in its entirety to read as follows:
- "4.B. Total disbursements made to Organization under this Subcontract by the City shall not exceed Twenty-Five Thousand Dollars (\$25,000.00) per year over the
