The City of Long Beach thanks you for taking this request into consideration.

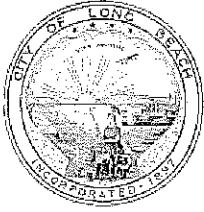

Subject: 5372 East 2nd Street, dba Me Soo Hungry, ABC License

On September 21, 2010, the City Council protested the application of Me Soo Hungry Incorporated, dba Me Soo Hungry, for an original On-Sale Beer and Wine Alcoholic Beverage Control License at 5372 East 2nd Street.

The protest was based on an over concentration of ABC licenses in the census tract. Upon receipt of additional community input, it was found that the neighborhood is in support of the granting of an ABC license at this location.

Therefore, I am requesting that the Council reconsider the action of September 21, 2010, and remove the protest in support of the license.

Recommended Action: Request the City Council reconsider the action of September 21, 2010, for an original ABC license application for Me Soo Hungry Incorporated, dba Me Soo Hungry, and approve the application with conditions.



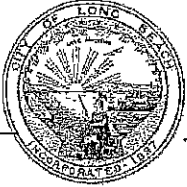
Subject: 5372 East 2nd Street, dba Me Soo Hungry, ABC License

I am submitting the following conditions for your consideration for an original application of an On-Sale Beer and Wine license for a bonafide eating place.

1. The petitioner(s) shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control.
2. The permittee shall not allow employees to discard trash or bottles into the outside dumpsters between the hours of 10 p.m. and 8 a.m.
3. There shall be no exterior advertising promoting or indicating the availability of alcoholic beverages.
4. Sound shall not be audible within fifty feet (50') from the exterior of the premises in any direction.
5. The permittee shall take reasonable measures to prohibit and prevent the loitering of persons immediately outside the establishment at all times.
6. Sales, service and consumption of alcoholic beverages shall be permitted only between the hours of 11:30 a.m. and 9:30 p.m. Sunday through Thursday and 11:30 a.m. and 10:00 p.m. Friday and Saturday.
7. The quarterly gross sales of alcoholic beverages shall not exceed the gross sales of food during the same period. The licensee shall at all times maintain records which reflect separately the gross sales of food and the gross sales of alcoholic beverages of the licensed business. Said records shall be kept no less frequently than on a quarterly basis and shall be made available to the Department on demand.
8. The sale of alcoholic beverages for consumption off the premises is strictly prohibited.
9. No "happy hour" type of reduced price alcoholic beverage promotion shall be allowed.

10. There shall be no pool or billiard tables, amusement machines, video game devices or television(s) in the premises at any time.





