THIS FIRST AMENDMENT TO AGREEMENT NO. 33600 is made and entered, in duplicate, as of July 13, 2016, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 16, 2014, by and between EDCO TRANSPORT SERVICES, LLC, a California limited liability company ("Consultant"), with a place of business at 2755 California Avenue, Signal Hill, California 90755, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with receiving, processing, transfer and disposal services; and

WHEREAS, City and Consultant entered Agreement No. 33600 (the "Agreement") whereby Consultant agreed to provide these services; and

WHEREAS, City and Consultant desire to extend the term to September 17, 2017;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the parties agree as follows:

1. Section of the Agreement is hereby amended to read as follows:
2. TERM. The term of this Agreement shall commence at midnight on September 18, 2014, and shall terminate at 11:59 p.m. on September 17, 2017, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33600 are ratified and confirmed and shall remain in full force and effect.
