## FIRST AMENDMENT TO AGREEMENT NO. 34678

THIS FIRST AMENDMENT TO AGREEMENT NO. 34678 is made and entered, in duplicate, as of October 20, 2017, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on July 11, 2017, by and between INTERWEST CONSULTING GROUP INC., a Colorado corporation ("Consultant"), with a place of business at 15140 Transistor Lane, Huntington Beach, California 92649, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City requires specialized services requiring unique skills to be performed in connection with as-needed plan review and inspection services; and

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 34678 (the "Agreement") whereby Consultant agreed to provide these services; and WHEREAS, the Parties desires to add \$120,000 to the Agreement;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

- 1. Section 1.A of the Agreement is hereby amended to read as follows:
- "A. Consultant shall furnish specialized services more particularly described in Exhibit "A", attached to this Agreement and incorporated by this reference, in accordance with the standards of the profession, and City shall pay for these services in the manner described below, not to exceed Two Hundred Thousand Dollars (\$200,000), at the rates or charges shown in Exhibit "B"."
- Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 34678 are ratified and confirmed and shall remain in full force and effect.
