

FIRST AMENDMENT TO CONTRACT NO. 34138

THIS FIRST AMENDMENT TO CONTRACT NO. 34138 is made and entered, in duplicate, as of August 9, 2017, for reference purposes only, pursuant to Resolution No. RES-15-0128, adopted by the City Council of the City of Long Beach at its meeting on October 6, 2015, by and between FORENSIC NURSING SPECIALISTS, INC., a California corporation ("Contractor"), with a place of business at 3373 Cerritos Avenue, Los Alamitos, California 90720, and the CITY OF LONG BEACH ("City"), a municipal corporation.

WHEREAS, the City requires assistance to provide medical examinations, evidence collection, and appropriate treatment with respect to victims of sexual assault; and

WHEREAS, City and Contractor (the "Parties") entered into Contract No. 34138 ("Contract") whereby Contractor agreed to provide medical examinations, evidence collection, and appropriate treatment with respect to victims of sexual assault; and

WHEREAS, the Parties wish to revise the annual Contract amount to reflect the amount approved by City Council on October 6, 2015;

NOW, THEREFORE, in consideration of the mutual terms and conditions contained herein, the parties agree as follows:

1. Section 4. of Agreement No. 34138 is hereby amended to read as follows:

"4. City shall pay Contractor hereunder in due course of payments of the City following the end of each calendar month and receipt from Contractor of invoices therefore, covering said services performed during said month for which payment has not heretofore been made by City to Contractor, with the following stipulation: In order for the City to maintain necessary cost accounting controls, all invoices covering said services must be submitted within thirty (30) days after the end of the month in which services were performed. Any invoices submitted after

1 this time period will not be paid by the City. The total compensation to be paid during  
2 the period from November 1, 2015, through October 30, 2017, the annual amount  
3 not exceed One Hundred Twenty Thousand Dollars (\$120,000.00)."

4 2. Except as expressly modified herein, all of the terms and conditions  
5 contained in Contract No. 34138 are ratified and confirmed and shall remain in full force  
6 and effect.
