

SECOND AMENDMENT TO AGREEMENT NO. 30263

THIS SECOND AMENDMENT TO AGREEMENT NO. 30263 is made and entered, in duplicate, as of March 1, 2012 for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on September 18, 2007, by and between URS CORPORATION doing business in California as URS CORPORATION AMERICAS, a Nevada corporation ("Consultant"), with a place of business at 2020 East First Street, Suite 400, Santa Ana, California 92705, and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, the parties entered Agreement No. 30263 whereby Consultant agreed to provide specialized services requiring unique skills to be performed in connection with Preparing Project Initiation Document (PID) and Project Report and Environmental Document (PA/ED) for the Realignment of the Shoemaker Bridge and Ramps ("Project"); and

WHEREAS, the parties desire to extend the term of the Agreement;

NOW, THEREFORE, in consideration of the mutual terms and conditions in Agreement No. 30263 and herein, the parties agree as follows:

1. Section 2 of Agreement No. 30263 is hereby amended to read as follows:

"2. TERM. The term of this Agreement shall commence at midnight on September 18, 2007, and shall terminate at 11:59 p.m. on December 31, 2012, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner."

2. Except as expressly amended herein, all terms and conditions in Agreement No. 30263 are ratified and confirmed and shall remain in full force and effect.
