Alfre Vaille, Sustainability Coordinator, reported that the City Council adopted the Green Building Ordinance for private development on May 5, 2009.

The Sustainability Team has also been working on programs related to the Stimulus, to take advantage of creating green jobs, as well as working on the Energy Efficiency Block Grant Program to organize which projects to submit.

Meredith Reynolds, Sustainability Coordinator, spoke regarding the Green Business Program kick-off beginning in August 2009, and the Green Restaurant Program.
