12	35347 (the "Agreement") whereby Contractor agreed to provide the specialized services		
13	as described in Request for Proposals No. PR18-113 for Lake Water Quality Management;		
14	and		
15	WHEREAS, the Parties entered into a First Amendment to the Agreement to		
16	extend the term one (1) additional year through September 30, 2021; and		
17	WHEREAS, the Parties entered into a Second Amendment to the Agreement		
18	to extend the term one (1) additional year through September 30, 2022; and		
19	WHEREAS, the Parties entered into a Third Amendment to the Agreement		
20	to extend the term one (1) additional year through September 30, 2023; and		
21	WHEREAS, the Parties desire to amend the annual contract amount to Two		
22	Hundred Twenty Thousand Dollars (\$220,000), and extend the term of the contract for one		
23	additional one year period through September 30, 2024;		
24	NOW, THEREFORE, in consideration of the mutual terms, covenants, and		
25	conditions herein contained, the Parties agree as follows:		
26	1. Section 1 of the Agreement is hereby amended to read as follows:

2. Section 2 of the Agreement is hereby amended to read as follows:

9 "2. <u>TERM</u>. The term of this Agreement shall commence at midnight on
10 October 1, 2019, and shall terminate at 11:59 p.m. on September 30, 2024, unless sooner
11 terminated as provided in this Agreement, or unless the services or the Project is
12 completed sooner."

3. Except as expressly modified herein, all of the terms and conditions
contained in this Agreement are ratified and confirmed and shall remain in full force and
effect.
