A RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF LONG BEACH, CALIFORNIA, APPROVING A NEW FAMILY SELF-SUFFICIENCY ACTION PLAN AND AUTHORIZING THE DEPUTY EXECUTIVE DIRECTOR TO TRANSMIT THE PLAN TO THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT(HUD)

WHEREAS, the Family Self-Sufficiency Program (“FSS Program”) enables HUD-assisted families to increase their earned income and reduce their dependency on welfare assistance and rental subsidies; and

WHEREAS, Public Housing Agencies (PHAs) work in collaboration with a Program Coordinating Committee (PCC) to secure commitments of public and private resources for the operation of the FSS Program, to develop the PHA’s FSS Action Plan, and to implement the program; and

WHEREAS, HUD regulations require that a Resident Advisory Board be established to provide input regarding the creation and amendment to the FSS Action Plan; and

WHEREAS, on April 21, 2021, the Resident Advisory Board provided input and thoughtful feedback on the FSS Action Plan and such recommendations and insights have been considered and addressed;

NOW, THEREFORE, the Housing Authority of the City of Long Beach, California resolves as follows:

Section 1. The Housing Authority adopts the new Family Self-Sufficiency Action Plan, attached hereto as Exhibit “A” and made a part hereof.

Section 2. The Deputy Executive Director is hereby directed to transmit to the Department of Housing and Urban Development a copy of the new Family Self-

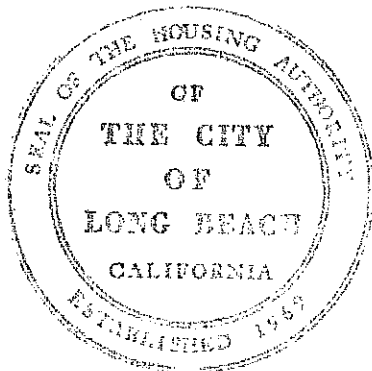
