1 FIRST AMENDMENT TO AGREEMENT

3 THIS FIRST AMENDMENT TO AGREEMENT is made and entered, in  
4 duplicate, as of October 6, 2006 for reference purposes only, pursuant to a minute order  
5 adopted by the City Council of the City of Long Beach at its meeting held on October  
6 10, 2006, by and between IMPACT ASSESSMENT, INC., a California corporation ("IAI"),  
7 and the CITY OF LONG BEACH, a municipal corporation ("CLB").

8 WHEREAS, IAI requires services involving education and outreach to reduce  
9 the consumption of contaminated fish in connection with the USEPA Palos Verdes Shelf  
10 Fish Contamination Project ("Project") and CLB is able and willing to provide these  
11 services; and

12 WHEREAS, the parties desire to extend the term of the Agreement and  
13 provide for compensation during the extended term;

14 NOW, THEREFORE, in consideration of the mutual terms and conditions in  
15 the Agreement and in this First Amendment, the parties agree as follows:

16 1. Section 1(A) of the Agreement is hereby amended to read as follows:

17 "A. CLB shall furnish the services more particularly set forth in the Scope  
18 of Work ("SOW") attached as Exhibit 'A' and incorporated by this reference and IAI shall  
19 pay for the services the amount of \$100,000.00."

20 2. Section 2 of the Agreement is hereby amended to read as follows:

21 "2. TERM. The term of this Agreement shall commence on January 14,  
22 2005, and shall terminate at 11:59 p.m. on December 31, 2006. The parties may amend  
23 this Agreement to extend the term, by mutual agreement, if IAI receives additional funding."

24 3. Except as expressly amended in this First Amendment, all terms and  
25 conditions in the Agreement are ratified and confirmed and shall remain in full force and  
26 effect.
