SIXTH AMENDMENT TO AGREEMENT NO. 33504

**33504**

THIS SIXTH AMENDMENT TO AGREEMENT NO. 33504 is made and entered, in duplicate, as of October 7, 2020, for reference purposes only, pursuant to a minute order adopted by the City Council of the City of Long Beach at its meeting on October 6, 2020, by and between RJM DESIGN GROUP, INC., a California corporation with a place of business at 31591 Camino Capistrano, San Juan Capistrano, California 92675 ("Consultant"), and the CITY OF LONG BEACH, a municipal corporation ("City").

WHEREAS, City and Consultant (the "Parties") entered into Agreement No. 33504 (the "Agreement") whereby Consultant agreed to provide as-needed landscape architectural services; and

WHEREAS, the Parties entered a First Amendment to the Agreement to increase the amount by \$750,000 for a total not to exceed amount of \$1,000,000; and

WHEREAS, the Parties entered into a Second Amendment to the Agreement to extend the term to August 1, 2017 and add \$50,000 for a total not to exceed amount of \$1,050,000; and

WHEREAS, the Parties entered into a Third Amendment to the Agreement to extend the term to August 1, 2018 and add \$50,000 for a total not to exceed amount of \$1,100,000; and

WHEREAS, the Parties entered into a Fourth Amendment to extend the term to August 1, 2019, update the City Representative and attach a revised rate sheet; and

WHEREAS, the Parties entered into a Fifth Amendment to the Agreement to extend the term to August 1, 2020; and

WHEREAS, the Parties desire to extend the term one (1) additional one-year period and add \$500,000 to the Agreement for a total not to exceed amount of \$1,600,000;

NOW, THEREFORE, in consideration of the mutual terms, covenants, and conditions herein contained, the Parties agree as follows:

1. Section 1.A. of the Agreement is hereby amended to read as follows:

1           “A. Consultant shall furnish specialized services more particularly  
2 described in Exhibit “A”, attached to this Agreement and incorporated by this reference, in  
3 accordance with the standards of the profession, and City shall pay for these services in  
4 the manner described below, not to exceed One Million Six Hundred Thousand Dollars  
5 (\$1,600,000), at the rates or charges shown in Exhibit “B”.”

6           2. Section 2 of the Agreement is hereby amended to read as follows:

7           “2. TERM. The term of this Agreement shall commence at midnight on  
8 August 1, 2014, and shall terminate at 11:59 p.m. on August 1, 2021, unless sooner  
9 terminated as provided in this Agreement, or unless the services or the Project is  
10 completed sooner.”

11           3. Except as expressly modified herein, all of the terms and conditions  
12 contained in Agreement No. 33504 are ratified and confirmed and shall remain in full force  
13 and effect.
