

1 THIRD AMENDMENT TO AGREEMENT NO. 33917

3 THIS THIRD AMENDMENT TO AGREEMENT NO. 33917 is made and
4 entered, in duplicate, as of June 6, 2018 for reference purposes only, pursuant to a
5 minute order adopted by the City Council of the City of Long Beach at its meeting on
6 June 2, 2015, by and between RANIA ALOMAR ARCHITECT, INC. DBA RA-DA, a
7 California corporation ("Consultant"), with a place of business at 7523 Norton Avenue,
8 West Hollywood, California, 90046, and the CITY OF LONG BEACH, a municipal
9 corporation ("City").

10 WHEREAS, City requires specialized services requiring unique skills to be
11 performed in connection with as-needed architectural services; and

12 WHEREAS, City and Consultant (the "Parties") entered into Agreement No.
13 33917 (the "Agreement") whereby Consultant agreed to provide these services; and

14 WHEREAS, the Parties entered into a First Amendment to the Agreement
15 to extend the term to July 19, 2018 and increase the total not to exceed amount; and

16 WHEREAS, the Parties entered into a Second Amendment to the
17 Agreement to add \$500,000; and

18 WHEREAS, the Parties desire to add \$1,300,000 for a total not to exceed
19 amount of \$3,200,000 and extend the term one (1) additional one-year period;

20 NOW, THEREFORE, in consideration of the mutual terms, covenants, and
21 conditions herein contained, the Parties agree as follows:

22 1. Section 1.A. of the Agreement is hereby amended to read as follows:

23 "A. Consultant shall furnish specialized services more particularly
24 described in Exhibit "A", attached to this Agreement and incorporated by this
25 reference, in accordance with the standards of the profession, and City shall pay
26 for these services in the manner described below, not to exceed Three Million Two
27 Hundred Thousand Dollars (\$3,200,000), at the rates or charges shown in Exhibit
28 "B"."

2. "2. TERM. The term of this Agreement shall commence at midnight on July 20, 2015, and shall terminate at 11:59 p.m. on July 19, 2019, unless sooner terminated as provided in this Agreement, or unless the services or the Project is completed sooner. The Parties have the option to extend the term one (1) additional one-year period."

3. Except as expressly modified herein, all of the terms and conditions contained in Agreement No. 33917 are ratified and confirmed and shall remain in full force and effect.
